TRADE PROGRAM LETTER OF AGREEMENT

This Trade Program Letter of Agreement (this "Agreement"), along with any terms and conditions set forth in the application form and other written materials provided to Designer (as defined herein) from time to time, sets forth the terms and conditions of the Trade Program of Ion Design Furniture Marketing Ltd., d/b/a Shelter Furniture, (collectively, the "Company"). The Trade Program and its governing terms and conditions are subject to change from time to time in the Company's discretion.

Once eligibility is met, and subject to the terms of this Agreement, Designers participating in this Trade Program will receive a 20% discount on any regular priced merchandise and a 10% discount on any discounted or on sale merchandise purchased at Shelter Furniture. Rights and rewards under this Agreement are nontransferable.

In addition to the above mentioned discounts upon enrollment and completion of 1 year of membership in the Trade Program, an annual rebate will be given to the Trade Program member in the form of an in-store credit to be redeemed by the member towards future purchases at Shelter Furniture. The rebate will be given henceforth after that on annual basis. The calculation of the amount of rebate is based upon net (not including HST or other applicable sales taxes) purchases made in the previous 12 month period prior to eligibility for the rebate. The Annual rebate will only be given in the form of an in-store credit and cannot be redeemed in any other form or method nor transferred into any other form or method. The rebate structure is as follows:

\$25,000 net purchases - 2% Rebate

\$35,000 net purchases - 3% Rebate

\$45,000 net purchases - 4% Rebate

\$50,000 net purchases or more - 5% Rebate

TERMS OF ELIGIBILITY

An applicant who is an accredited professional designer will be eligible for participation in this Trade Program (and referenced herein as a "Designer") upon approval by the Company after presentation of a completed and signed application form and one of the following:

TERMS AND CONDITIONS

- The Designer's name and business address must be provided on the application. Note that the eligible Designer must be an individual and 1 not a firm or entity; multiple individuals employed by a single firm or entity may apply individually by submitting individual application materials and gaining approval, but the firm or entity itself may not.

- The Designer is the only person authorized to make purchases using his/her account number and Designer Rewards Card. З
- 4 The Company reserves the right to review and terminate a Designer's eligibility if the Company believes, in its sole discretion, that the
- Designer has violated the terms of this Agreement or the Trade Program generally or is no longer eligible to participate in the program. DISCOUNT

- Discount is applied in stores at the point of sale on merchandise for sale at or through the Company's store only (including full-price, 1 reduced-price or closeout items) at the then-prevailing retail price as stated.
- Discount is not applicable to purchases of Gift Cards, services, shipping and handling, taxes or other fees and non-merchandise charges. 2
- Discount does not apply to any purchases made prior to the enrollment in the Trade Program. 3 4
- Discount is not valid with any other offer or promotional program. Prices for merchandise eligible for discount are set for each item and are non-negotiable. 5
- 6 All qualifying purchases must be made by the Designer only. Phone orders and purchases made (whether in store or otherwise) by any other person are not eligible for discount.
- 7 Merchandise eligible for discount is priced in Canadian dollars, and the corresponding discount is calculated in Canadian dollars.
