The Seller wishes to sell certain items to Szerer Ventures, LLC under the terms and conditions of this agreement outline by the TERMS OF THE BUY BACK PURCHASE AGREEMENT BETWEEN PARTIES:

1. Payment

The Seller will receive payment for the agreed amount owed from Szerer Ventures, LLC on the business day after the items arrive at the business premises of Szerer Ventures, LLC ONLY after the goods sent are evaluated for authenticity. Szerer Ventures, LLC has the right to withhold payment for the goods for a reasonable amount of time (here defined as two weeks, but may be longer), until the goods can be properly authenticated.

2. Shipping

Seller is responsible for shipping the agreed upon item/s to SZERER VENTURES, LLC in good condition. All shipping of goods to Szerer Ventures, LLC must have an industry standard tracking number and insurance on the goods shipped. Any items that do not include insurance can be subject to return to the Seller (at the expense of the Seller) without any payment from Szerer

Ventures, LLC for the goods. Szerer Ventures, LLC reserves the right to return any items that are not in good condition which will be in the sole discretion of Szerer Ventures, LLC. Szerer Ventures, LC will notify the Seller when the goods have arrived at the place of the business of Szerer Ventures, LLC. Any cost for return of items due to poor condition of the goods will be incurred by the Seller.

3. Ownership & Authenticity

The Seller attests to the authenticity of all agreed upon items, and has not knowingly requested the resale of counterfeit goods. The Seller attests that they maintain proper legal ownership and are in legal possession of all goods, which Szerer Ventures, LLC has agreed to purchase.

4. Loss or Damage

Seller will ensure that items are insured from risks of fire, theft, flood, accidental damage or breakage, any acts of nature resulting in any damage to the property, until agreed upon items are delivered to Szerer Ventures, LLC.

Both parties have read and understand all statements included in this agreement. This agreement may not be revised or amended without written consent of both the seller and Szerer Ventures. LLC.
