# Handling and Application

Shake well before using.



MIXING:

**APPLICATION**:

Allow basecoat to flash according to manufacturer's instructions.

Coats:2 full coats or 3 medium coatsDistance:6-8"Flash time:3-5 minutes between coats

Allow 40903 to dry for at least 1 hour before handling.

**IMPORTANT**: If too much **40903** is applied or it is applied before the basecoat has flashed off properly, re-wetting of the basecoat could occur.

**NOTE:** If clogging develops, remove spray button with a twisting motion and clean with material compliant with VOC regulations in your area. Do not stick pin or other object into can. Gently replace spray button with top of can and spray button pointed away from you.

**NOTE:** After each use, turn can upside down and spray several seconds to clear spray tip.

#### STORAGE:



**40903 1K HS CLEAR** should be stored in a cool dry place with adequate ventilation away from heat, sparks and flames. The shelf life for **40903** is 5 years when stored under normal conditions.
