SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

3.2 POTENTIAL HEALTH EFFECTS

Eye Contact:

SECTION 4: FIRST AID MEASURES

4.1 FIRST AID PROCEDURES

The following first aid recommendations are based on an assumption that appropriate personal and industrial hygiene practices are followed.

Eye Contact: Immediately flush eyes with large amounts of water for at least 15 minutes. DO NOT ATTEMPT TO REMOVE MOLTEN MATERIAL. Get immediate medical attention.

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures

Evacuate unprotected and untrained personnel from hazard area. The spill should be cleaned up by qualified personnel. Ventilate the area with fresh air. For large spill, or spills in confined spaces, provide mechanical ventilation to disperse or exhaust vapors, in accordance with good industrial hygiene practice. Warning! 6.2. Environmental precautions

SECTION 7: HANDLING AND STORAGE

7.1 HANDLING

AIR SAMPLING DATA: 3M conducted air monitoring of a similar product to determine exposure to MDI. The monitoring yielded an exposure of 0.0012ppm MDI in the operator's breathing zone. The adhesive was spray applied using a Nordson Model 560 bulk applicator at 20psi, 245 degrees F and an adhesive flow-rate of 1.5 pounds/hour. Exposure time was 20 minutes. Monitoring was conducted in 20ft X 10ft X 20ft, room with no local exhaust ventilation.
