### **3.2 POTENTIAL HEALTH EFFECTS**

#### **Eye Contact:**

### 4.1 FIRST AID PROCEDURES

# **SECTION 6: ACCIDENTAL RELEASE MEASURES**

# **SECTION 7: HANDLING AND STORAGE**

### 7.1 HANDLING
