- 1. There will be a 18% consignment fee from the sales price of each sneaker sold through our website. Consignor will earn 82% of the sales price after each sneaker is sold. Consignor will only be charged for the consignment fee if your sneaker sells. There is no cost to you if your sneaker doesn't sell.
- 2. Consignors will have the rights to withdraw their sneaker(s) at any time. However, there will be a \$15 service fee for each sneaker only if consignor chooses to withdraw their sneaker before the initial 14 day consignment period. This fee covers photographs, listing, and any other related costs to promote the sale of the sneaker. For example, if we list your sneaker on our website on January 1st, you can choose to withdraw your sneaker on or after January 15th at NO CHARGE. Consignor is responsible for the shipping fee if consignor decides to withdraw the sneaker from our website. Shipping and handling fee must be received before we can ship your sneaker back to you; such fee will be determined by our carrier such as FedEx, USPS, etc. We will not overcharge shipping when your sneaker(s) are being shipped back to you.
- 3. Consignors will be paid as soon as your sneaker is sold and have received an email notification from us. We usually send you an email notification immediately after your sneaker is sold. If you choose to get paid by check, then we will send you a check by mail to the address listed on this agreement. For security purposes, we cannot send your check to an address other than the one entered on this agreement and the check will only be made payable to the consignor's name. If you choose to get paid by PayPal, then we will deposit the funds into you PayPal account entered on this agreement.
- 4. If the merchandise we receive from consignor is different than what was approved, we will ship back the item to the consignor at consignor's own expense. (I.e. counterfeit,

different sneaker, fake sneaker, replicas, different condition, etc.)

- 5. All pricing is decided by the consignor. We will give you recommendations to help you sell your sneaker quicker. When we send you the approval email, recommendations will be acknowledged if there is any. Final pricing for each sneaker should be shown on the confirmation email that you receive from us.
- 6. Consignor is responsible for address change. Consignor must call us to make an address change and must be able to verify all of your information when asked to do so before we can change your address.
- 7. Cash4Sneakers will put best efforts to promote the sale of the sneaker(s) such as, but not limited to, web ads, blogs, Facebook, twitter, etc.)
- 8. It is the responsibility of the consignor to maintain all records of consigned merchandise email to check on the status of your sale sneaker(s) once in a while.
- 9. To withdraw your sneakers, you will have to pay for shipping. Please make your money order or check payable to 'Cash4Sneakers'. Money order and check may take anywhere from 1-14 business days to clear depending on where the payment is coming from. Once your check clears our bank account, we will ship your unsold merchandise back to you.
- 10. USED SNEAKERS: We have the rights to describe used sneaker(s) in detail as how we see and inspect them. Descriptions include, but are not limited to, scratches, stains, marks, cleanliness, and etc. Anything visible will be described even if they are minor.
- 11. SNEAKERS: Please consider double boxing your shoes. This can protect the original shoe box from any damages during transit.
- 12. Cash4Sneakers is not responsible for any loss or damages occur during shipping. Purchase of insurance is recommended.
- 13. Consignor agrees all sneakers that are being sent to Cash4Sneakers for consignment are 100% authentic and that consignor holds legal possession of these goods.
