## POLICIES AND PROCEDURES:

In order to ensure the safety of your pets and our other guests, we require that all guests adhere to the following Policies and Procedures:

**Application & Waiver:** All dogs must have a complete, up-to-date and approved application, Waiver of Liability on file.

**Drop-Off/Pick-Up:** Owner must provide written authorization to allow anyone else to pick up their dog, and people who are authorized by you will be required to present valid picture identification to ensure the safety of your dog. Dogs not picked up by closing time will be crated and hourly fee of \$15 will apply. No overnight stays.

**Reservations & Cancellation Policy:** Camp space is limited. Pre-payment or credit card on file is required to ensure your spot in camp ("Packages" automatically get priority reservations). "Single Day" cancellations must be made 24 hours prior or cancellation fee of \$20.00 per dog will apply. "Packages" require 14 days' notice or forfeiture of payment will apply.

**Bedding:** Bedding is not provided for crates

**Training above and beyond the standard core home manners:** Counselors have a structured training course and may not be qualified to train other methods. Core Training Calendar is posted

**Feeding:** If you would like your dog to be fed during their stay, we request that you bring their regular food to avoid causing possible digestive issues (diarrhea, etc). We ask that you label the meal with your Dog's name and any special feeding instructions (feeding time, adding water, elevating food, etc.). If you forget to bring your dog's food and would still like to have them fed, we will gladly provide our premium house food for \$2 per meal (please note that changing your dog's regular food will most likely result in diarrhea). Also, we provide our guests with small treats throughout the day – please let us know on the Application if you do not want your dog to have any treats.

**Health:** All dogs must be clean and in good health, and must not have fleas (we strongly recommend that your dog receive some form of monthly topical flea treatment plan- please consult your veterinarian for more information about flea treatment options. Or order Over-the-Counter Flea Treatment from our online store). Owners will certify that their dogs are in good health and have not been ill with a communicable condition in the last 30 days. Dogs that have been ill with a communicable condition in the last 30 days will require a veterinary certificate of health to be admitted or re-admitted.

**Interview/Evaluation:** Your dog must complete a one-time screening/temperament test with Paws-Abilities LLC staff member to ensure proper handling during your dogs' stay (safety is our top priority, and aggressive or unfriendly behavior can be dangerous for both dogs and staff members alike). Evaluations MUST be scheduled with us in advance-please call ahead for availability (253-486-6557). The test will take up 20 minutes. There is a non-refundable \$25 Application & Evaluation fee per dog which must be paid for in advanced when scheduling your test. This fee is forfeited if you do not provide us with 48 hours' notice of cancellation and do not show up at your scheduled evaluation test time. Please note that we MUST have proof of current vaccinations and a negative fecal examine (within the last 60 days) in order to conduct the test with your dog.

**Legal Stuff:** Our Policies, Procedures, Services and Rates may change from time to time. While we will attempt to notify you of these changes, it is ultimately your responsibility to check back on our website regularly so that you are aware of our most current Policies, Procedures, Services and Rates. We reserve the right to refuse service to anyone at our sole discretion.

**Medication:** We are happy to give oral or topical medication to your dog, but require the following: all medications must be in their original container and must include your dog's name, the name and strength of the medication, and directions including dosage, number of times per day, how it is to be given, illness to be treated, areas to be treated, etc. Any dog with special needs may incur additional charges.

**Nametags & Collars:** All dogs must be wearing their "every day" collar with a name tag and must be on leash upon entry. Please bring any training gear (separate collar & training leash).

**Nail Trims, Bath & Grooming:** Grooming services performed by *Bark about It*. *Bark about it* sets prices for their services. For more information contact them at 253-964-8300.

**Risks:** Owners understand that Paws-Abilities follows the AKC Responsible Dog Ownership Pledge, however, acknowledge that dogs are unpredictable in behavior, and are aware of the risks involved and assume all risks.

**Vaccination Policy:** All canine guests must have up-to-date vaccinations in order to be permitted into camp. Owners must submit written proof of current DHPP (Distemper, Hepatitis, Parainfluenza and Parvovirus), Bordetella (kennel cough) and Rabies vaccinations as well as an annual negative fecal test. For new clients, the fecal test must be conducted within the last 90 days prior to your evaluation. We do accept titer tests provided that they are documented by your veterinarian and are updated annually. You can either bring us a copy of your dog's vaccination & fecal records, or simply have your Vet email the records to us at [info@everydoghas.com](mailto:info@everydoghas.com). Puppies must be a minimum of 10 weeks of age and are required to have their second set of DHPP and Bordetella vaccinations, and are required to have their Rabies vaccination at 16 weeks of age. It is the ongoing responsibility of the owner to provide verification that vaccinations are current-we will make every effort to remind you before your dog's vaccinations expire.
