### OVERVIEW

This website is operated on behalf of **Linus Coraggio** (hereafter “the artist”). Throughout the site, the terms “we”, “us” and “our” refer to linuscoraggio.com. Linus Coraggio offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site and/or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Terms of Service”, “terms”), including those additional terms and conditions and policies referenced herein and/or available by hyperlink. These Terms of Service apply to all users of the site, including without limitation users who are browsers, vendors, customers, merchants, and/or contributors of content.

### SECTION 1: WHAT DO WE DO WITH YOUR INFORMATION?

When you purchase something from our store, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address.

When you browse our store, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

Email marketing: with your permission, we may send you emails about our store, new products and other updates.

### Payment

If you choose a direct payment gateway to complete your purchase, then Shopify stores your credit card data. It is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS). Your purchase transaction data is stored only as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is deleted.

## REFUNDS/RETURNS POLICY STATEMENT

### SECTION 1: POLICY AND LIMITATIONS

To request a refund or exchange and to make arrangements for the return shipping of the original item, please contact us via the website's Contact page or by emailing the artist at [linuscoraggio@verizon.net](mailto:linuscoraggio@verizon.net) *immediately*. This request must be made within **3 business days** of your having received the item. If more than 3 business days have gone by since you received your purchase and you have not yet contacted us, unfortunately we can't offer you a refund or exchange. Furthermore, we will not accept return shipments without prior arrangement or notification.

### SECTION 2: RETURN SHIPPING

The artist will make every effort to arrange for the least expensive form of shipping that will maintain the artwork in the best possible condition. You, the purchaser, however, will be responsible for paying the shipping costs for returning the item. Shipping costs are non-refundable.

### SECTION 3: REPAIR

In the event that your purchased artwork was damaged in shipping and returned to the artist by prior arrangement, Linus Coraggio agrees to repair the item and to pay for shipping the repaired item to you.
