1. This gazebo is not a permanent structure and should be disassembled and stored away after use.
2. Do not repack your gazebo until completely dry.
3. This gazebo must be assembled by two adults or more.
4. This gazebo must not be left erect in windy conditions.
5. Loading limit of the hook is 10 lbs.
6. Steel components for garden accessories and furniture are treated with rust inhibiting paint that protects them from rust. However, due to the nature of steel, surface oxidation (rusting) will occur if this protective coating is scratched. This is a natural process. To minimize this condition, it is recommended that care be taken when assembling and handling the product in order to prevent the paint from being scratched. If scratching or damage occurs, it is recommended that the area be touched-up immediately with rust inhibiting paint, which is included in the package. Surface rust can be removed easily using a very light application of common cooking oil. If surface oxidation (rusting) occurs and no measures are taken to correct it, the oxidation may start dripping on the deck or patio, which may cause damaging strains that may be difficult to remove.

Fabric

Fabric on cushions, slings, and umbrellas is warranted against separation at the seams. Fading, mildew, and/or discoloration due to exposure to elements, chemicals, and spills are not covered.

Powder coat and/or Paint

The finish is warranted against blistering, peeling, or cracking. Fading resulting from exposure to elements, chemicals, and spills are not covered. Scratches and chips due to normal wear and use are not covered.

Freight & Packing

The manufacturer will be responsible for shipping, handling, and packaging charges for all valid warranty claims.

Care & Maintenance

Be careful to never allow water build up in frames as this will cause corrosion and freeze damage in cold climates. Wash all frames with a solution of mild soap and water. Rinse with clean water and dry with a soft absorbent cloth towel. Frames can be treated with a liquid wax for maximum protection against UV rays and/or salty damp air. If your set includes cushions, slings, and/or an umbrella, they may be cleaned by hand with a solution of soap and water with a clean water rinse.

Identify all parts packaged in carton against the parts list. Remove all protective materials and place parts on a non-abrasive surface to avoid scratching. Caution

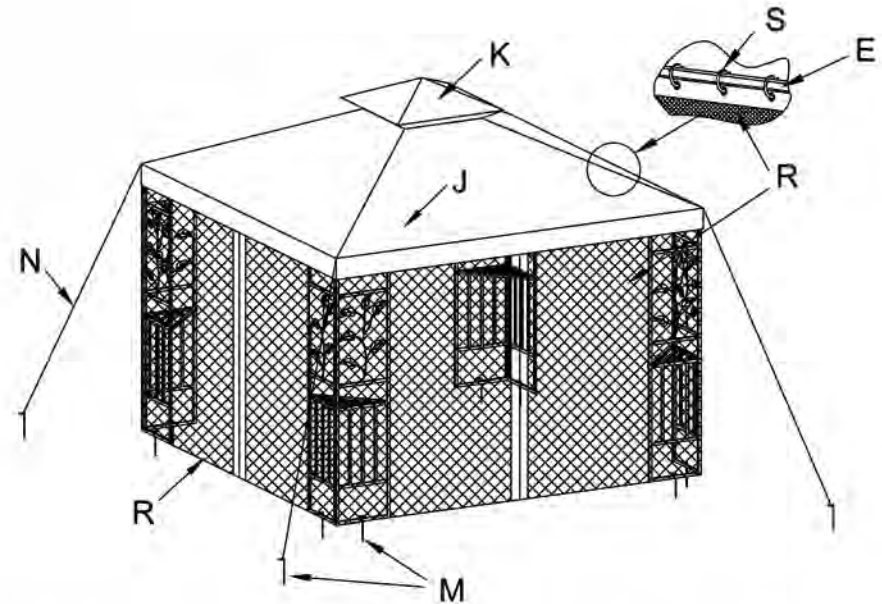
Read all the instructions before assembly. Failure to do so may result in faulty assembly and potential injury! Assemble product on a soft, non-abrasive surface such as a carpet or cardboard to avoid damaging the item. Seek assistance to assemble bulky or heavy items. After final alignment, make sure all bolts and nuts are securely tightened with screw covers pressed in place.

Assemble gazebo on a level site with sufficient space. To prevent accidents and possible serious injuries, keep children and pets away on the assembly site during assembly and erection. This gazebo is a garden ornament, not a play set. Do not use the gazebo for purposes other than original purpose of the product.

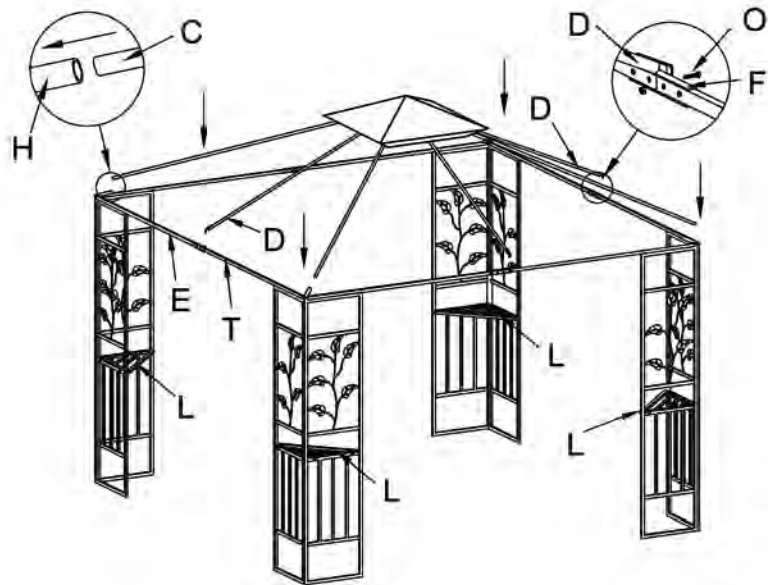
Put the Main Canopy (J) on the top of the gazebo from one side to another. Slip the rib ends into the pockets of the canopy. Velcro the Small Canopy (K) to the Main Canopy (J). Hammer the Stakes (M) through the bottom of the panels into the ground. To enforce stability, loop Rope (N) onto the corner of the Main Canopy (J) and tie the other end of the Rope (N) to Stake (M).

Insert the Plastic Rings (S) onto the metal grommets on the top of the Netting (R). Hook the Plastic Rings (S) around the outside of the gazebo on the Cross Beams (E & T).

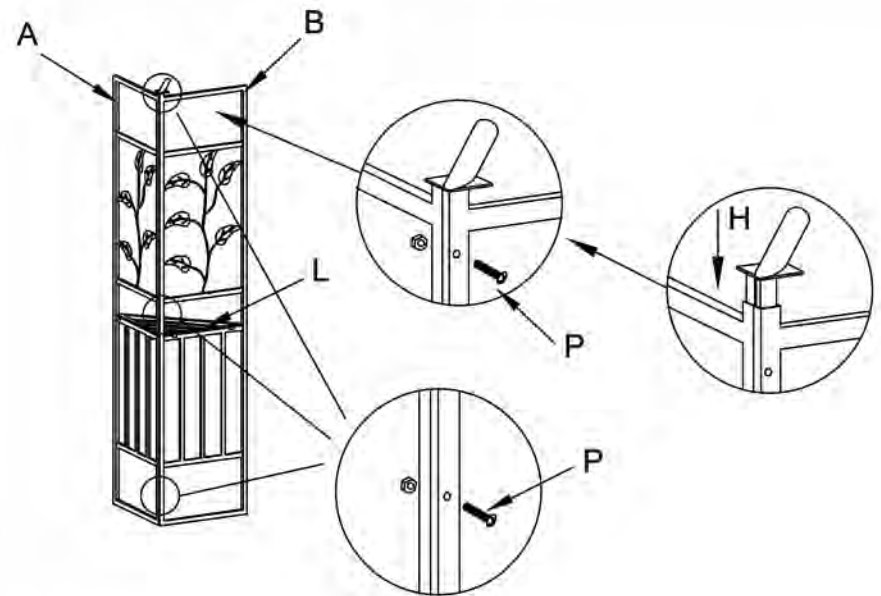


Carefully place the newly formed roof on top of the gazebo. Connect the Corner Canopy Rib (C) to the Corner Connector (H) that is on the top corner of the panels. Secure the Canopy Middle Rib (D) to the Cross Beam Connector (F). Assemble by using M6 x 25mm screw & nut (O).

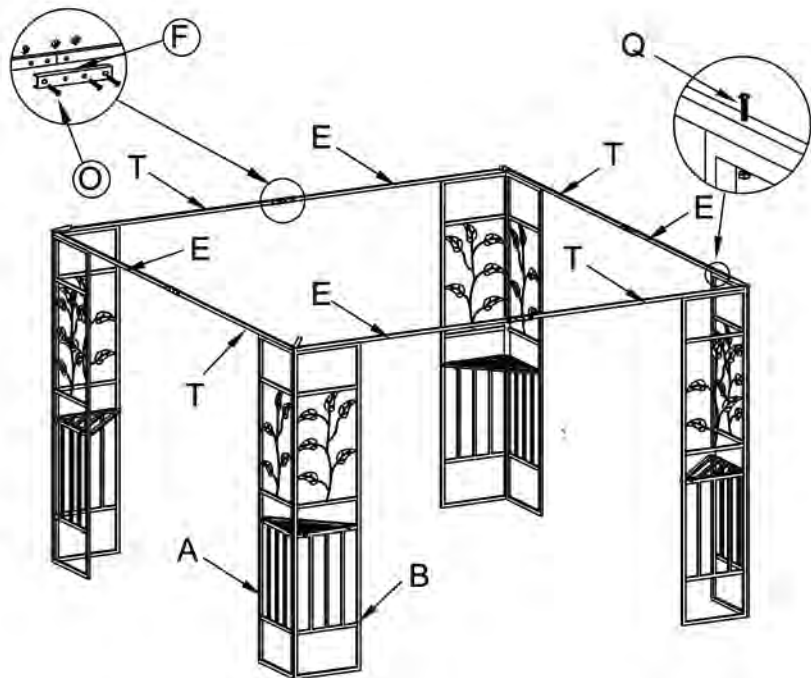


At the lower portion of the the panel, using two M6 x 40mm Screws & Nuts (P), screw the 17" Panel (B) onto 16" Panel (A). At the top corner, first place the Corner Connector (H) into the corner of the attached panels, then use M6 x 40mm Screws & Nuts (P) to screw all the pieces together. Continue finishing one set of panels by adding the Corner Shelf (L) to the panels. See picture above.

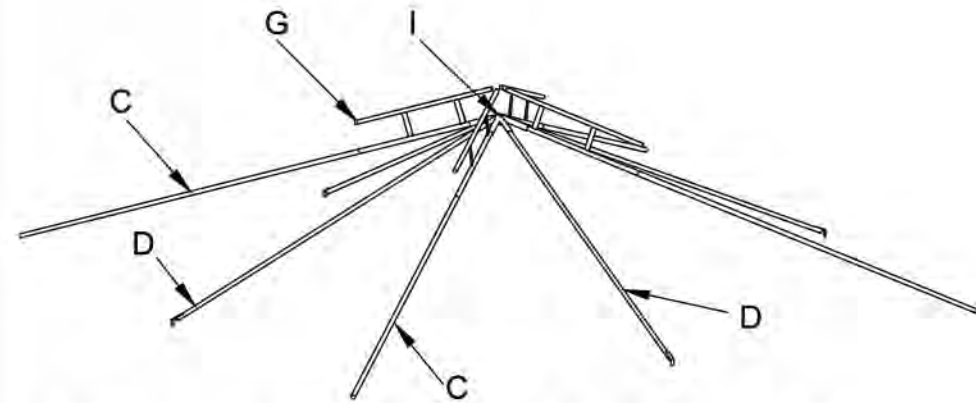


Connect Cross Beam (E) & (T) together with Cross Beam Connector (F), secure by using 3 pcs M6 x 25mm Screws & Nuts (O). Leave one screw hole empty to be used on page 10. Place the attached crossbeams on top of the panels. Cross Beam (E) goes on top of panel (B) and Cross Beam (T) goes on top of Panel (A). Use M6 x 48mm Screws & Nuts (Q) to secure the cross beams to the panels. Please see above picture for reference.














Alternate inserting the Canopy Middle Rib (D) and Canopy Two Tier Rib (G) into Connector (I). Make sure the spring loaded button is snapped through the slot and locked in place on the connector. The Canopy Middle Rib (D) should be placed into the smaller pipe of the Connector (I). Place Corner Canopy Rib (C) into the Canopy Two Tier Rib (G).

Place the Small Canopy (K) onto the Two Tier Ribs (G). Slip the rib ends into the corner pockets of the canopy.

Loading limit of the hook is 10 lbs.

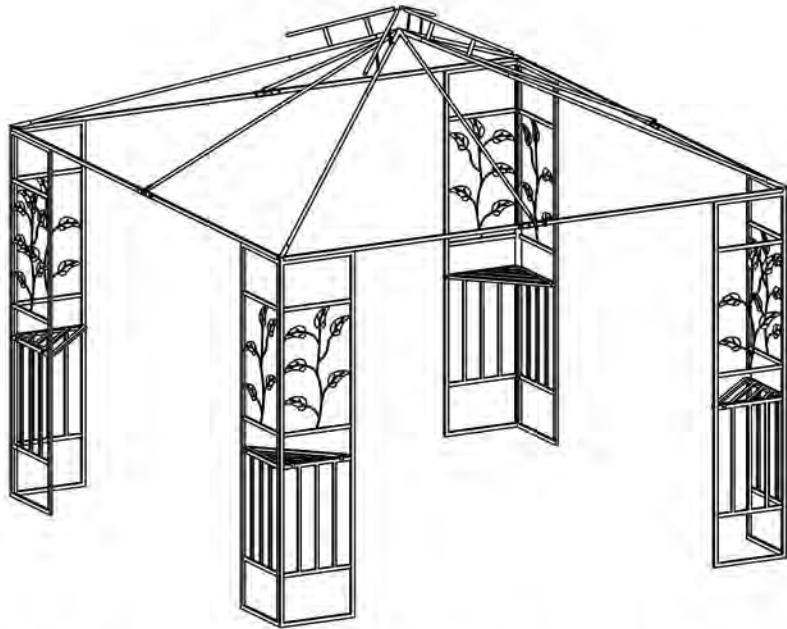










Note: In case of adverse weather conditions or strong wind, please remove the Main Canopy (J) from the gazebo.

This gazebo is susceptible to wind. Please make sure each rope at the corners is tightly staked down and each stake at the bottom of the panel is hammered down. In the event of adverse weather conditions, it is highly recommended that the Main Canopy is removed from the gazebo so that no damage will occur to the gazebo.

This product is designed for leisure use only and is not a shelter against adverse weather conditions.
