Dr. Arthur Croft coauthored the first textbook on whiplash, *Whiplash Injuries: The Cervical Acceleration/Deceleration Syndrome*. He has written or contributed to sixteen textbooks, and he is the author or co-author of more than 350 professional papers on whiplash and other medical topics. He is a Doctor of Chiropractic, is board certified in orthopaedics (American Board of Chiropractic Orthopaedists), and is certified in traffic accident reconstruction (Northwestern University's Traffic Institute).

Dr. Croft is a grant proposal reviewer at the National Institutes of Health (NIH), and has worked on several research projects at the RAND Corporation. Dr. Croft serves in an editorial and/or manuscript reviewer capacity for the *Society of Automotive Engineers (SAE)*; *Journal of Forensic and Legal Medicine*; *Journal of Chiropractic Medicine*; *Journal of Whiplash Related Disorders*; *Journal of Manipulative and Physiological Therapeutics*; *Journal of Musculoskeletal Pain*; *Journal of the American Chiropractic Association*; and the journals *Spine*, *Accident Analysis & Prevention*, and *Archives of Physical Medicine & Rehabilitation*.

He received an Emmy nomination in 1991 from the National Academy of Television Arts and Sciences for his role in the production Whiplash.

He lectures extensively in the United States and abroad and teaches an award-winning four-module program on traumatic injuries caused by auto accidents.

Michael D. Freeman MD PhD MPH FAAS is a forensic epidemiologist and consultant in forensic medicine, working in civil, criminal, and academic venues. He has provided expert testimony more than 1,000 times in a wide variety of civil cases, including injury and death litigation, automotive and other product liability, toxic tort litigation, life expectancy, and medical negligence cases, as well as in homicide and other criminal matters.

Dr. Freeman has published around 200 scientific papers, books, and book chapters, primarily focusing on issues relating to forensic applications of epidemiology and general and specific causation. He has published research on the topics of traffic crash-related injury and death, injury biomechanics and injury causation, genocide, cancer epidemiology, chronic pain mechanisms, and adult autologous stem cell therapy, among others. Dr. Freeman is the co-editor and co-author of the authoritative text on forensic applications of epidemiology; *Forensic Epidemiology: Principles and Practice*, published in 2016.

His three-step approach to injury causation investigation has been adopted by U.S. courts as the generally accepted methodology, as described in the 2016 10th circuit US DCA Etherton decision.

Dr. Freeman holds academic appointments at Maastricht University Medical Center and Oregon Health & Science University School of Medicine. He serves as an Affiliate Medical Examiner with the Allegheny County Medical Examiner's office in Pittsburgh, PA, and is a fellow of the American Academy of Forensic Sciences. Dr. Freeman is currently a Fulbright Fellow with the U.S. Department of State, in the area of forensic medicine.

Dr. Freeman holds a doctor of medicine degree from Umeå University in Sweden and a Ph.D. and master's degree in epidemiology from Oregon State University. He completed a two-year fellowship in forensic pathology through Umeå University and the Allegheny County Office of the Medical Examiner.

DOROTHY CLAY SIMS

Dorothy consults with attorneys throughout the U.S., to provide methods of expert testimony cross-examination and also to conduct cross-examinations of expert witnesses.

Dorothy's practice includes numerous other projects and philanthropic work. She is frequently invited to in-house seminars for lawyers and law firms on researching and cross-examining. She has given over 350 speeches internationally on medical/legal issues throughout the world and is often invited as the state keynote speaker. She has spoken in almost every state in the United States including Hawaii and Alaska. She has also been a featured speaker in Paris, France; Jaipur, India; and twice in Kyoto, Japan.

She has authored chapters in books with individuals such as David Ball and Don Keenan as well as Dr. Michael Freeman. Dorothy donates a percentage of her book profits various organizations including the American Association for Justice and the International Federation for Human Rights. Her book, *Exposing Deceptive Defense Doctors* was a best seller for three years in a row and went into reprint status soon after publication, unheard of in the industry. She has also authored two children's books for parents who are injured. The books are available for free upon request. She has also authored articles in national publications to include the *Champion Magazine*, *Trial Magazine* (The American Association for Justice Journal) most recently on the cover of the December, 2015 issue, and *Brain Injury Professional*.

Dorothy initially represented miners in Kentucky who were denied black lung benefits. Going down into the bowels of a mine in Eastern Kentucky, she felt vibrations as the miners "shot coal" (exploded portions of the face to loosen the coal). Despite wearing a mask, her trip left her coughing and sneezing coal dust for days; leading to a newfound respect for the dreaded pneumoconiosis suffered by miners who had spent decades in the mines.

After representing coal miners, Dorothy began representing workers who were injured and denied medical care. She co-founded the Florida Workers' Advocates—the state's first watchdog over the insurance industry devoted to serving injured—and eventually served as president.

For over a decade, Sims volunteered time to lobby on behalf of the injured and was the first woman to be elected Chair of the Florida Bar Worker's Compensation Section in its twenty-two-year history. She also served as President of the Marion County Bar Association.

Keith R. Mitnik was born in Eustis, Florida in 1959. He graduated from Eustis High School in 1977. He graduated from UCF Magna Cum Laude in 1981 with a degree in Allied Legal Services. He graduated from FSU Law School with honors 1984. Upon graduation he was selected to train under one of the premier Trial Attorneys in Central Florida. Within two years he was named a partner by his mentor. He remained in the firm of Robertson, Williams, Mitnik and McDonald until 1992, when he formed The Law Firm of Peed and Mitnik. In 1997 he joined the Law Firm of Morgan & Morgan and is now one of the owners.

Keith Mitnik is Senior Trial Lawyer for Morgan & Morgan. He is designated to assist other members of the firm on their trials; as a result, he tries a large number of cases a year.

He has handled many high-profile cases and has been interviewed by Mike Wallace on *60 Minutes*. Over the years, his list of clients included judges, elected officials, law firms, and world-famous musicians. He has handled such high profile cases as the suit against Brittany Spears by her former manager, the suit by the Backstreet Boys against their former manager, the suit by Harlem Globetrotters legends including Curly Neal and Meadowlark Lemon against The Harlem Globetrotters, the civil suit against Casey Anthony, and the "Tailwind" case against CNN and Time Magazine (one of the leading defamation cases of the last decade). He has been honored as a member of the Florida Legal Elite, Florida's "Super Lawyers", Best Lawyers in America (2013 Lawyers of the Year), and Martindale's Bar Registry of Preeminent Lawyers.

Mr. Mitnik has obtained a long list of verdicts in excess of a \$1 million. In the last few years, he has jury verdicts of \$1 million, \$1.35 million, \$2.4 million, \$2.7 million, \$5.1 million, \$18.1 million, \$27 million, \$40 million, and a \$90 million (which was the seventh largest verdict in America for 2010).
