1. **PROMOTION PERIOD:** The SPD Concepts Car Giveaway 005 (the "Giveaway" or "Promotion") begins June 14, 2019 and ends at 11:59:59 PM PT on September 14, 2019 (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Promotion
2. **ELIGIBILITY:** This Promotion is open only to legal residents of the 50 United States & the District of Columbia (excluding NY, FL, AK and HI) and residents of Canada (excluding the province of Quebec), who are licensed drivers, 18 years of age or older (or legal age of majority in the state/province in which they reside). **Void in the states of AK, FL, HI, NY, the province of Quebec, and where prohibited.** Employees of SPD Concepts, its affiliates, subsidiaries, advertising, promotion and internet agencies (collectively "Released Parties") and their immediate family members (spouse, parent, child, sibling, grandparent) and/or those living in the same household of each are not eligible. If a purchase is returned prior to the Promotion drawing, entry will be voided. Your purchase transaction must be received by 11:59:59 PM PT on September 14, 2019 to be eligible to receive entries.

- B. **MAIL-IN ENTRY; NO PURCHASE NECESSARY.** To enter without making a purchase, on a plain piece of 3"x5" paper, hand print your first and last name, street address city, state/province, zip/postal code, date of birth (mm/dd/yyyy), e-mail address plus daytime telephone number including area code. Then, on the opposite side of your entry, in 25 words or fewer, complete the following sentence: "I want to win the 2006 WRX STI because...."
