## 4. First aid measures

### 4.1. Description of first aid measures

#### General information

### 5. Firefighting measures

#### 5.1. Extinguishing media

##### Suitable extinguishing media

Recommended: alcohol resistant foam, CO<sub>2</sub>, powders, water spray/mist

### Advice on protection against fire and explosion

Vapours can form an explosive mixture with air. Vapours are heavier than air and may spread along floors.
