This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

## **Section 4 - First Aid Measures**

#### General Information:

## **Section 5 - Fire Fighting Measures**

Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. ## Section 10 - Stability and Reactivity
