NOTE: Refer to the Original Equipment Manufacturers instructions that came with your DISC for Assembly and Warnings. Failure to read and understand all assembly and warning instructions can result in serious injury or death.

ALWAYS make sure you wear safety gear while operating your ATV/UTV.

ALWAYS read and understand the manufacturer's **WARNINGS & INSTRUCTIONS** before using the ATV/UTV DISC. Maintain the **WARNINGS & INSTRUCTIONS** for later review as needed, for instructions on usage to anyone borrowing or using your ATV/UTV DISC, or to pass on when selling the it.

Never exceed the manufactures weight rating of your ATV/UTV hitch . If you are unsure , always refer to the ATV/UTV owners manual.

ALWAYS use CAUTION when operating any ATV/UTV with accessories or additional implements secured to the ATV/UTV.

DO NOT place yourself or any parts of your body under , between or on any part of any implement being used .

Use CAUTION when removing and replacing implements that are heavy. Assistance may be required.

NEVER operate your ATV/UTV on steep inclines while using the DISC, tipping or roll overs can occur.

Inspect all nut and bolt assemblies, hardware, and components for damaged, missing, or loose parts.

Inspect for any structural damage to product. (Return to factory for repair or discard product if any damage is found.) Inspect entire product for any rust, corrosion, cracks, freezing, excessive heat or rotting damage that may affect the safety of your product. Discard any questionable product.

Inspect entire product for any structural damage - pay close attention to all weld locations. (Return to factory for repair or discard product if any damage is found.)

Using correct wrenches inspect all nut & bolt assembly locations and snug up any that may be loose.

Be careful not to crush tubing when tightening!

LIMITED WARRANTY POLICY

Limited Warranty Periods

- **Hunting Equipment:** 1 Year (12 months) from the date of purchase.
- Trailer Products: 1 Year (12 months) from the original date of purchase.
- Hydraulic Cylinders, Rams, Hose Assemblies, and Fittings: 2 Years (24 months) from the date of purchase.
- Sub-component Items: Many sub-component items are warranted separately by the respective manufactures and are covered by warranty of their manufacturer. Examples of such items may include safety harnesses and tie-down systems, wheels, tires, axles, bearings, lights, straps, chain, hardware and like items. The sub-components original manufactures product warranty supersedes and takes precedence over this limited warranty policy.

NOTE: ALL WARRANTY CLAIMS MUST BE PREAPPROVED BY THE MANUFACTURER (THE COMPANY) TO BE VALID.

Products are warranted to be free of defects in materials and/or workmanship for the warranty period. Under this limited warranty, the Company shall be limited to repairing or replacing, at its option, for the warranty period, those parts returned to the factory, freight prepaid, which in the opinion of the Company shall prove to be defective in materials or workmanship, under normal use and service. This warranty will not apply unless the product is installed, used and maintained in accordance with the Manufacturers installation, operation and maintenance instructions.

This warranty applies to the ORIGINAL purchaser only, and is non-transferable.
