

## **OPEN** ZSportsterPro

When turning knobs remember: Righty tighty (not too tight), and Lefty Lucy (Just loose enough to re-position)



1. CARRY MODE. All knobs tightened in transit



2. SET UP, LOOSEN KNOBS Not too loose, start at base knobs. Work your way up.



3. RAISE BASE LEGS
Raise to almost 90° and then
thghten knobs. lockdown
ZBaseBones to base.



4. MOVE TOP ZBONES AND TABLE ASSEMBLY UP as shown



5. TILT UP ADJUST TABLETOP as shown



**6.** ADJUST TABLE TOP Adjustment knob is located under tabletop.



 UNLOCK MID-KNOBS. Adjust table hight and then re-tighten for sitting or standing modes.



8. SITTING POSITION: TABLET / TABLE position lower hight for adjustible sitting mode



9. PUSH OUT TABLET BRACKET



10. CHANGING TABLET BRACKET MODES
SPIN BRACKET FROM SITTING MODE TO STANDING MODE



12. ONLY AFTER TIGHTENED can you then add electronics and equiptment.

- 3. Put ZStand into the desired position and tighten before adding electronics or equiptment.
- 4. Do not exceed working load limit of 30 lbs (Tablet, tracpad, keyboard, laptop, small projector...)
- Remove computer tablet and electronics before closing or adjusting ZStand.
- 6. Do not stand on ZStand.
- 7. Regularly inspect the ZStand for loose knobs or missing screws or fatigue, cracks and general instability.




## CLOSE **ZSportsterPro**

When turning knobs remember: Righty tighty (not too tight), and Lefty Lucy (Just loose enough to re-position)



1. REMOVE ALL ELECTONICS AND **EQUIPTMENT** before disassembly



2. 10. CHANGING TABLET BRACKET TO CLOSING MODE



3. PUSH IN HEAD ASSEMBLY IN PLACE as shown. Then tighten knobs.



5. EXTEND TABLE PLATFORM UP



6. TILT TABLETOP FOR CLOSING by unlocking table knob under table then re-lock in correct close position



7. FLIP UP TABLE as shown in #.7. Then tighten ZTable knob



7. FLIP DOWN TABLE ASSEMBLY



9. FLIP DOWN TOP ZBONES and then tighten mid knobs.



10. LOOEN BASE KNOBS. FLIP DOWN BASE BONES and then re-tighten knobs.



11. MAKE SURE ALL KNOBS ARE **TIGHTENED** 



12. ALL KNOBS ARE TIGHTENED and now you're ready to go!
