CONDITIONS:

Under Section 42(2)(b) of the Act, the licensee is authorised to dispatch liquor from premises other than the licensed premises. Details of all dispatch sites must be made available for inspection by an authorised Officer.

The licence authorises the sale of wine produced by the licensee either personally or under contract. Details of all contracts entered into must be available for inspection by an authorised officer.

1. Samples shall be sold or supplied in disposable containers only unless suitable glass washing facilities are provided accordance with the requirements of the Food Act 1985 and the Food Hygiene Regulations 1990.
2. Hand washing facilities are to be provided in accordance with the requirements of the Food Act 1985 and the Food Hygiene Regulations 1990.
3. The provision of samples of liquor shall be supervised at all times.

IMPORTANT: The licensee is obliged to maintain all essential safety provisions as required by Regulation 76 of the Regulations made under the Development Act 1993.
