4. FIRST-AID MEASURES

Inhalation

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Collect the material and place into a suitable labelled container. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Industrial application: Avoid exposure. Use only in a well ventilated area. Keep containers tightly closed. Prevent the build up of dusts, mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Industrial application: Protect from freezing. Store in a cool, dry, well-ventilated area, out of direct sunlight. Ensure that storage conditions comply with applicable local and national regulations.

No exposure standards have been established for the mixture. However, over-exposure to some chemicals may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions and should be kept to the least possible levels.

Appropriate Engineering Controls

No special engineering controls required. Industrial applications: Use with good general ventilation. If mists or vapours are produced, local exhaust ventilation should be used.

Respiratory Protection
