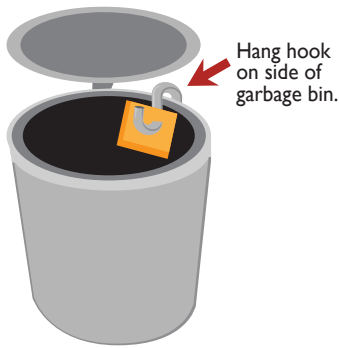

DIRECTIONS FOR USE

Always read label directions and precautions prior to use. Maggie's Farm Garbage Refresh blocks will work best in covered or enclosed garbage bins. Just before use, remove the wrapper from one of the individually wrapped blocks. Use the enclosed metal hook to hang the block. Depending on the design of your garbage bin, push the smaller or the larger end of the hook through the hole in the block and hang the other end over the edge of the bin. Close the lid on the bin. Replace the block weekly, or when most of the fragrance is gone. Spent blocks can be placed in the garbage disposal for a burst of lemony freshness. Drop the block in with or without food. Run the disposal when needed to process food waste.



STORAGE & DISPOSAL

Store unused blocks in their original wrappers in this box. Store box in a cool, dry place away from children and pets. Dispose of blocks by placing in the trash, or in the garbage disposal as noted under DIRECTIONS FOR USE.
