Get Maine Lobster 12 Days of Christmas Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

- 1. **SPONSOR and ADMINISTRATOR**: Get Maine Lobster 12 Days of Christmas Sweepstakes (the "**Sweepstakes**") is sponsored by Black Point Seafood, LLC (the "**Sponsor**" or "**Administrator**").
- 2. **OFFICIAL RULES**: These are the official rules (the "<u>Official Rules</u>") for the Sweepstakes. By entering any of the Sweepstakes, entrants agree that they can be contacted by phone or email regarding the Sweepstakes, and to be bound by these official rules and all decisions of the Sponsor relating to the Sweepstakes, which shall be final and binding on entrants.
- 3. **SWEEPSTAKES ENTRY PERIOD**: The Sweepstakes begins on December 2, 2024 at 11:59 PM Eastern Time ("**ET**") and ends on December 19, 2024 at 11:59 PM ET (the "**Sweepstakes Period**"). The Administrator's computer server is the official time-keeping device for the Sweepstakes.
- 4. **ELIGIBILITY**: The Sweepstakes is open only to legal residents of the 50 United States of America and District of Columbia and Canada (excluding residents of the Province of Quebec) who are 18 years of age or older, or the age of majority in the jurisdiction in which they reside, whichever is older, at the time of entry. In the event of a dispute in connection with the identity of the individual who submitted an Online Entry, the entry will be deemed to have been submitted by the authorized account holder of the e-mail account identified on the Online Entry form. The authorized account holder is deemed to be the natural person who is assigned to an e-mail address by an Internet access provider, service provider, or other online organization that is responsible for assigning e-mail addresses

for the domain associated with the submitted e-mail address. All Entries become the property of Sponsor and will not be acknowledged or returned. Sponsor is not liable for Entries that are lost, late, misdirected, incomplete, garbled, incompletely received, mutilated, or illegible, for any reason.

- 6. **<u>DETERMINATION OF THE WINNER</u>**: One (1) potential Grand Prize winner will be selected in a random drawing from among those eligible Entries received by the Sponsor during the Sweepstakes Period. Prizes are awarded "as is" with no warranty or guarantee, either express or implied by Sponsor. Drawing will be conducted by the Administrator on the Drawing Date and the results of the drawing will determine the provisional winners. Each provisional winner will be notified by phone, email or regular mail. If the provisional winner does not respond to the Sponsor by phone or email within fourteen (14) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, Sponsor reserves the right to randomly choose an alternate winner from the pool of remaining eligible Entries. The first eligible provisional winner that Sponsor successfully contacts in person by telephone or by email and who claims the Grand Prize in accordance with these Official Rules will be declared the final winner of the Grand Prize. Any winner may waive the right to receive a prize. The return of any prize notification as undeliverable will result in disqualification, the forfeiture of all interest in the prize, and selection of a substitute winner from among all remaining eligible Entries.
