However our biggest message is to let them know, "the sky's the limit". In addition, over 1 Million people are living in poverty within the State of Georgia. Forty five percent of the residents surrounding specific schools are considered below or at poverty level. Studies have shown that individuals that live in poverty are less likely to contribute to economic growth and will instead turn to violence, poor employment opportunities, and little to no academic achievement.

Let's Beat the Odds

- Less than 1% of Fortune 500 CEOs are women and/or African American.
- National Science Foundation reported that black men represented just 3% of scientists and engineers working in their field.
- Only 16% of financial advisers were raised in low income housing which leads to limited resources of gaining financial advice.
