



Enerworks Solar Collector: Limited 18 year warranty

ENERWORKS INC. warrants to the original owner, the solar collector manufactured by Enerworks to be free from defects in materials for a period of eighteen (18) years from the date of installation. If any solar collector should be found to be defective due to faulty materials; and Enerworks Inc. is notified within thirty (30) days of the discovery of such a condition, Enerworks Inc. will, at its option, either repair or replace or provide parts to repair such panels subject to the following conditions:

1. Enerworks Inc.'s obligation hereunder becomes effective only if the enclosed warranty or a reasonable facsimile is fully completed by the owner and returned to warrantor within thirty (30) days after the date of purchase by the owner. This Limited Warranty goes exclusively to the original owner and is with respect to the original installation only.
2. The owner has notified Enerworks Inc., or its authorized agent in writing of any defects with the materials covered by this warranty.
3. Costs of shipping are the sole responsibility of the owner, when replacement parts are shipped to the owner, or when a panel is returned to Enerworks Inc.
4. Installation has been performed in accordance with Enerworks Inc. installation instructions and the expressed procedures for winterization and summarization are followed.
5. This warranty does not apply to conditions resulting from failure to provide reasonable and necessary maintenance, or to conditions resulting from repair or alteration that changes the original product design or for uses that the product was not designed for. Abuse, neglect, accident, freezing or acts of God will void this warranty.
6. The Limited Warranty excludes the cost of labour to remove or replace any defective solar collector or installation of replacement parts.
7. This Limited Warranty does not cover consequential damages such as damage to your home, loss of time, inconvenience or loss of use of the solar collectors or any incidental expenses resulting from any breach of the express warranty.

TERMS OF WARRANTY

Enerworks Inc. will either repair, replace or provide replacement parts to repair manufacturing defect in the solar collector, provided you pay to Enerworks Inc. the difference between the suggested retail price of the materials at the time of the warranty claim and the prorated portion of the original suggested retail price according to the following schedule:

All other warranties expressed or implied are void.

Winterizaton must be done after your pool is closed.

- 1) Go to the highest point of the collectors and pipes and open the top corner end cap. Remove the opposite bottom corner end cap. Without disturbing the top and bottom rows of headers, work your way along the panels and gently lift the rubber from top to bottom. If in doubt you can open a section and drain out excess water. Blowing the lines may not remove all of the water.
- 2) Open all the end caps at down pipes, pump house and blow any underground lines. Make sure that no water remains in any low pipes, sags in pipe valleys or any part of the system. Re-attach the end cap to ensure nothing enters the header.
- 3) Valves must be turned to be halfway open. On motorized valves, turn switch to TEST and let valve turn halfway. Pull the electric cord.
- 4) A general inspection of the roof at this time is wise. Check for loose lag bolts and strapping. Remove leaves and debris that might block the run-off of rain or snow.

Summerization is done if the system is left for a prolonged period of inactivity in extreme heat conditions in excess of 150° F. This prevents non-circulating water from becoming stagnant and promoting bacterial growth. The use of a drain down valve and end cap, and a one way check valve is necessary. Follow steps 1-3 as for winterization.
