

## **STRUCTURE CYCLEWORKS DEMO BIKE AGREEMENT**

(Deed of Acknowledgement and Waiver of Liability, Indemnity and Voluntary Assumption of Risk)

At my request, Structure Cycleworks International will permit me to use Structure Cycleworks products or equipment.

Conditional to being permitted to use Structure Cycleworks products or equipment, I agree to be bound by the terms, conditions and effect of this Deed of Acknowledgment and Waiver of Liability, Indemnity and Voluntary Assumption of Risk (the 'Deed').

I acknowledge that:

- I am competent to perform a safety check, and will personally perform a safety check of the product or products prior to my use. This includes, but is not limited to, configuration of the brakes, as I acknowledge the existence of differing conventions on the connection between left and right levers and front and rear brake calipers.
- I am competent to safely use the product or products in questions and will observe safe riding practices and obey all laws and best practices.
- I will wear all appropriate safety equipment at all times, including an approved helmet in good condition.
- I am in good health and do not suffer from any cardiovascular, respiratory, musculoskeletal, neurological, or other conditions which may make operation of this equipment unsafe to me, other persons, or the equipment.
- This Deed serves as a warning that cycling is an inherently dangerous activity, presenting risks of injury or death that can include falling, colliding with other riders or vehicles, encountering hidden obstacles or varying terrain, and/or malfunction of the equipment.
- By signing this Deed, I voluntarily and expressly assume all the risks associated with use of this equipment, including the risk of injury or death.
- I acknowledge that I am responsible for returning the equipment in the same condition in which I received it. Should the equipment be damaged in any way or if it is lost or stolen while in my care, I hereby authorize Structure Cycleworks to charge me the total cost of repairing or replacing the equipment, at the sole discretion of Structure Cycleworks.
- I have carefully read, or had someone else read to me, this Deed and I understood this Deed and agree with all statements contained herein. I am also aware that by signing this Deed, it may affect the legal rights and liabilities of myself, my heirs, next of kin, executors, administrators and successors.

On my own behalf and on behalf of my heirs, assigns and personal representatives, I hereby: (a) fully and forever discharge and release Structure Cycleworks and its related companies (being the "releasees"); and (b) agree to indemnify and keep indemnified the releasees, from any and all liability, claim, damage, loss, cost or expense arising directly or indirectly from my demonstration ride and/or use of the demonstration bicycle (however caused and whether fatal or otherwise).

I expressly agree that the forgoing agreement shall be construed to provide the parties being released with the broadest relief possible. If any portion is held invalid, the balance shall continue in full legal force and effect. This Deed shall be governed by the laws of the United States of America and Canada.
