Promo Period

The raffle promotion will run from April 15-May 15, 2024.

Participating Establishments

The official website at marksandspencer.com.ph and 20 M&S stores nationwide: Alabang Town Center, Central Square, Eastwood, Gateway Mall, Glorietta 4, Greenbelt 5, Power Plant Mall, Robinsons Place Manila, Shangri-la Plaza Mall, SM Aura Premier, SM Mall of Asia, SM Megamall, SM City North EDSA, Trinoma, Abreeza Mall, Marquee Mall, Ayala Cebu, Limketkai Center, Marks & Spencer Outlet Store and SM Lanang Premier.

Eligibility

- 1) The promo is open to all customers in the Philippines who are at least 18 years old.
- 2) Employees of the franchisee of Marks & Spencer which is Rustan Marketing Specialists, Inc. (RMSI), their affiliates, their suppliers, their PR firm and advertising agency, including their relatives up to the 2nd degree of consanguinity or affinity are disqualified from joining this promotion as an entry, winner and/or as a companion of the winner.

How to Join

- 1) For every single receipt, minimum spend of P 5,000 a customer will be entitled to 1 raffle entry.
- 2) To qualify for the promo, the customer is required to fill out an online entry form to join the raffle. The link to this form is accessible in the following ways for eligible entries:
 - a) In-store: the store staff will hand you the store's device to fill out the online entry form.
 - b) Online: the customer must click on the banner that can be found on the order confirmation email. It will lead to the online form.
- 3) The customer must fill out the online form with his name (as seen on card if via card payment), birthdate, invoice/SI/OR number/order number, contact number, address, email, date of purchase, M&S branch location, tick box consenting to the data privacy act and tick box confirming that all submitted details are correct and that the customer is responsible for ensuring all details are correct.
- 4) Notification of the raffle entry confirmation will be sent through the customer's registered email.
- 5) There is no limit to the number of raffle entries that may be earned per customer.
- 6) For store purchases, the customer must keep his physical receipt until May 24, 2024 as it will serve as his proof of eligibility and entry should he be announced the winner.

Date and Venue of Draw

Announcement of the Winner

- 1) Public announcement of the verified and eligible winner is on May 24, 2024, Friday through M&S Philippines' social media accounts.
- 2) Winner will be notified through his registered email and mobile number.

Prizes

- 1) The winner will avail of the following prizes:
 - a) Clothing shopping spree from Marks & Spencer worth P35,000.
 - b) One (1) Sunlight Ecotourism Island Resort (SETIR) gift certificate for one (1) winner and his/her plus one that includes the following:
