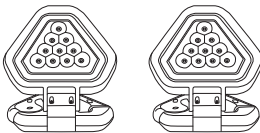
CLEANING:

Clean the outside of the fixture with a soft, dry cloth or slightly dampened clean cloth. Never use a cleaner with chemicals, solvents, or harsh abrasives to clean the product.

- LED light output is strong enough to injury human eyes. Precautions must be taken to prevent looking directly at the LEDs with diffuser [cover] removed for more than a few seconds.
- Do not tamper with or attempt to repair the LED component. The light source is designed for this specific application and should not be serviced by untrained personnel. Contact the Koda Customer Service team if any servicing is required.

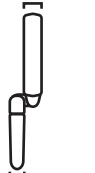

BATTERY SAFETY:

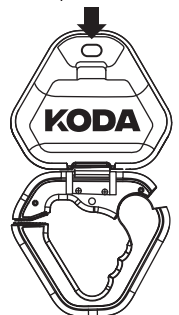
OPERATION:

Before using the light, please open the cover on the back and insert four AA batteries provided.

Press the Mode / Power Button once to turn on the light and cycle through the different brightness levels. The sequence of the light modes are: High - Low - Off.

Turn off the light when not in use. Remove all batteries if you are planning to store the light for a long period of time.

MOUNTING METHOD:

There are various mounting methods for the Portable LED Worklight:

Clamp mount - using the handle clamp, the light can be mounted on a bench, table, and any other surface that the light can be clamped to.

Hanger mount - with the handle closed, the light can be hung through the middle of the clamp.

Magnet mount - where a magnetized surface is available, the light can be mounted in place.

Screw mount - there are two screw holes on the light that allow it to be mounted in place. Screws not included.

Tripod mount - where a tripod is available, the light can be rotated and tightened in place to any standard tripod. Tripod not included.
