Fits: 98 - 06 Road Glide Fairings

## nstructions

 Remove clear headlight cover and outer fairing (See Section 2-97 (FLTR) in your Harley Davidson® Service Manual).

Note: Wire harness comes with 3 & 6 pin connector. Use appropriate plugs for vour application.

- 2. Locate front turn signal connector plug or plugs and disconnect front turn signals.
- 3. Plug the male end of the new wire harness into the 6-pin or 3-pin connector on the main wire harness. If you elect to use your existing turn signals in conjunction with the Illumabezel™, plug the 6-pin or 3-pin connector from your turn signals into the female plug on the new wire harness.

NOTE: If using the Illumabezel<sup>™</sup> turn signals only, you will need to purchase a load equalizer (P/N CV-4821) separately.

- 4. Route the long black wire leads between the back of the headlight and the fairing on the right and left side. The lead with the black & brown wire is the right side, and the lead with the purple & black wire is the left side.
- Reinstall outer fairing (See Section 2-97 (FLTR) in your Harley Davidson® Service Manual).
- 6. Plug the leads into the lights on the Illumabezel<sup>™</sup> and snap the Illumabezel<sup>™</sup> into place. Top first, then bottom.
