By taking receipt of products you agree to the below Terms & Conditions.

ORDER CONDITIONS:

- Puffin reserves the right to ship orders up to 7 days in advance of the requested ship date.
- Prices and terms are subject to change without notice. Please contact your rep for updates.

ORDER ALTERATIONS OR CANCELLATIONS:

- Cancellation of shipments may result in loss of eligible special program terms.
- Any alterations or cancellations of purchase orders must be emailed to <u>sales@puffincoolers.com</u>. Items returned without authorization may be subject to a restocking fee of 10% and all shipping charges.

DISCOUNTS AND FREIGHT ELIGIBILITY:

• Accounts must be in good credit standing to be eligible for any discounts, terms, free freight or Puffin promotions.

MERCHANDISE CLAIMS AND RETURNS:

- Upon approval, merchandise may be accepted for credit or exchange if defective or due to fulfillment error.
- Claims must be made within fourteen (14) days after receipt of merchandise.
- No merchandise will be accepted for return without bearing our RETURN AUTHORIZATION, available by emailing sales@puffincoolers.com.

PAYMENT TERMS, CREDIT AND SHIPPING POLICIES:

CREDIT CARD TERMS: credit card authorization will be required prior to order fulfillment.

LATE PAYMENT: Late payment of invoices may result in loss of all eligible programs, discounts, freight terms and conditions.

PRICE CHANGES: Puffin reserves the right to change prices when necessary, without notice.

CREDIT LIMITS: Credit limits will be established for customers based on payment history and review of financial information provided with the credit application.

PAST DUE ACCOUNTS: Accounts with past due invoices will receive credit card terms only. A service charge of 1.5% per month will be charged on past due accounts. Accounts past due will be charged a \$30 collection fee upon collection. It is our policy to withhold shipments to past due accounts until they are resolved. When merchandise is in limited supply, shipping priority will be determined by a customer's payment history.

FREIGHT POLICY: Shipments are made F.O.B Hildale, UT.

GOODS LOST, DAMAGED OR DELAYED: Our responsibility is complete when we deliver the order to the carrier. All claims must be filed with the carrier when goods are lost or damaged in transit.

AUCTION SITES

It is a violation of this policy for approved dealers to offer any Puffin products for sale via eBay auctions, Yahoo auctions, UBid or other auction-type sales methods.

Puffin reserves the right to discontinue selling to dealers failing to comply with any of the above policy.

MAP Policy

MINIMUM ADVERTISED PRICE (MAP) GUIDELINES:

Puffin has established MAP on certain products within the Puffin product line as indicated in the wholesale price list. Puffin independently monitors MAP compliance and reserves the right to discontinue selling to dealers failing to comply with our minimum advertised prices. This includes retailers having purchased products from a distributor or directly from Puffin. Our unilateral policy includes but is not limited to newspapers, internet, mailed flyers, television, radio, direct mail etc.

Our MAP pricing is in effect from January 1, 2020 through December 31, 2020. Any dealer violating the Puffin MAP policy, waives their right to participate in any discount or freight programs.

ACCEPTED PROMOTIONAL PERIODS:

We will not be offering promotional periods for 2020 in an effort to maintain inventory levels to be retailed at MAP for all retailers. This will be reconsidered for 2021.

Styles identified as "discontinued" or "close-out" are exempt from non-promotional periods as long as they are clearly identified as prior season product or discontinued product and are separated from in-line product. Dealers may not present "range pricing" that combines discontinued product with in-line product (i.e. \$10.99 - \$15.00 for discontinued or in-line products).
