DIRECTIONS FOR USE

Shake or agitate container before use. This product may be mixed with liquid fertilizers. Dilute with water before mixing. Fill the spray tank to half full with water, turn on agitation, then add EarthMAX® Organic Foliar & Soil Additive. If desired, add liquid fertilizers then complete filling tank.

Agitation is recommended during application. A jar compatibility test should be performed on unknown combinations prior to mixing and application. Apply in sufficient water to ensure thorough coverage. Apply irrigation within 18 hours after application.

Ornamentals – For Smaller Tender Ornamentals: Use a dilution rate of 2 oz. per gallon of water every 2 – 4 weeks. Do not apply if temperature falls below 50° F. For stressed ornamentals, apply at a rate of 12 oz. per 1000 square feet every 2 – 4 weeks. Do not apply if temperature falls below 50° F.

Agriculture Crops: Apply 0.5-1.5 gallons per 100 gallons. Repeat every 2 - 4 weeks as necessary. Apply in sufficient water to ensure thorough coverage. Do not apply if temperature falls below 50° F.
