Introduction

Most people understand that we have an immune system and that it is responsible for keeping us healthy but how much do you really know about it?

The word immune comes from the Latin word *immunis*, meaning “exempt”, "free" or "untouched". It is understood to be the system that protects the body like a guardian from harmful influence and is essential for our survival.

The immune system is a complex intricate and fascinating network made up of different organs, cells, microorganisms and proteins. There are many different systems in the body including nervous system, digestive system, circulatory system, blood system etc. These systems are obviously not entirely independent nor mutually exclusive. All systems, including the immune system rely on our microbiome and engage in each other and there can be overlapping between them. The homeostasis or harmony in these systems will determine overall immunity.

When toxins and heavy metals accumulate in the body the overburden immune system cannot keep up. A weak immune system is currently recognized by pathogenic microbe growth and it is believed that these pathogens are causing most of our diseases. New research however, is revealing that pathogenic growth is not the cause of our disease, but rather the cleanup crew doing its utmost to restore balance within a corrupted system.

Common examples of a failing immune system are flu and viral infections, autoimmune diseases, cancer and chronic inflammations, including allergies, arthritis, asthma, and others with obvious signs of inflammation, but also to Alzheimer's, anxiety, chronic fatigue, depression, emphysema, fibromyalgia, heart disease, obesity, osteoporosis and stroke where you may not notice an inflammation.

New research is revealing that all health deterioration has a common link, being mainly caused by a combination of disturbed microbiome, inferior nutrition, inherited weaknesses, pollution, excessive stress and negative mental-emotional aspects. Our nutrition greatly affects the quality of our immune system and our mental-emotional aspect, which in turn, has a significant impact on the type and location of any developing health problem.

Further contributions to overall health and immunity stem from our family background. We are strongly affected by what our parents and grandparents ate, thought and felt, and by the infections and diseases with which they were afflicted. What is a Virus

According to Wikipedia: “A virus is a small infectious agent that replicates only inside the living cells of an organism. Viruses can infect all types of life forms, from animals and plants to microorganisms, including bacteria and archaea.”

An alternate view is offered by German biologist **Dr. Stefan Lanka**. Since the early 1990s, he has been at the forefront of challenging the medical theory claiming that viruses are the cause of infectious diseases such as hepatitis, AIDS, the flu, polio, herpes, or measles. Based on his studies in virology, Dr. Lanka discovered that viruses are vital components of simple life-forms that do not exist in complex organisms such as humans, animals, or plants. His research shows that the viruses believed to cause “viral infections” are in reality ordinary cell particles that have been misinterpreted as constituents of the viruses in question. **Dr. Lanka** also determined that viruses don’t have a destructive effect on the host, as commonly believed. These findings are in full accordance with the discoveries of **Dr. Ryke Geerd Hamer** who demonstrated already in the 1980s that contrary to the standard theory, microbes do not harm the organism but play instead a supportive role during the healing process of diseases (see *Fourth Biological Law of the New Medicine*).


The Beneficial Role of Microbes

Another aspect of Dr. Hamer’s research regards the role of microbes during disease development. This, in short, is what he found (Fourth Biological Law): Microbes such as fungi, bacteria, and viruses are only active during the healing phase, and how they operate is full accordance with evolutionary logic. Tubercular bacteria, for example, inhabit only specific controlled tissues. Their function during the repair phase is to decompose tumors that are no longer required (tumors form as a containment for toxins) e.g., lung tumors, colon tumors, kidney tumors, prostate tumors, uterus tumors, breast gland tumors, melanomas, and mesothelioma. Tubercular bacteria are essential for breaking down the buildup of “disposable cells” that proliferated for a biological reason during the *conflict-active phase*. If the required bacteria are not available, due to vaccination, overuse of antibiotics, or chemotherapy treatment, the tumor cannot disintegrate properly. As a result, it stays in place and encapsulates harmlessly. Detected in a routine

check-up, however, such an encapsulated growth can lead to a “cancer” diagnosis and, potentially create a new conflict shock with new symptoms. By understanding the biological laws of disease development this potential can be virtually eliminated.

Any doubt about Dr Hamer’s credibility needs to be countered by his extraordinary overall 98% success rate of “curing” not only his own testicular cancer but also that of hundreds, if not thousands of his patients.

The Role of Viruses

While bacteria break down tumor cells that are no longer needed, viruses appear to be involved exclusively in the healing process of cerebral-cortex-controlled tissues (e.g., bronchi, nasal membrane, stomach lining, lining of the bile ducts, and epidermis). Hepatitis, pneumonia, herpes, influenza, and the stomach flu are indications that a “virulent” but natural healing process is running its course. Concerning the role of viruses, Dr. Hamer prefers to speak of “hypothetical

viruses” since lately the existence of viruses is called into question. This would be in line with Dr. Hamer’s earlier findings that the reconstruction and restoration process of ulcerated or necrotized tissue still occurs, even if the tissue related viruses are not present. The dilemma in which conventional medicine finds itself is that by failing to recognize the two-phase pattern of every disease, the first, conflict-active phase, routinely gets overlooked. Since microbes are only active during the healing phase, and since the activity of microbes is typically accompanied by swelling, fever, pus, discharge, and pain, microbes are considered malevolent and the cause of infectious diseases. But microbes do not cause the disease. After all, it is our organism that employs the microbes to optimize the healing process. Microbes can, of course, be transmitted, but they remain dormant until the person is in the healing phase of the same type of conflict.

In light of this understanding, perhaps the reason Nascent Iodine is so effective at resolving any type of influenza virus, has more to do with clearing the toxins from the body so that it does not require the virus activity.

What is an Infection?

We are continually exposed to toxins, antigens (an antigen is a molecule capable of inducing an immune response), chemicals, heavy metals etc. When our immune system is working properly and not overly burdened by toxins, we may not even notice an incoming issue but if we have an under or over-active immune system, we are at a much greater risk of developing a health issue.

The current view maintains that an infection is caused by a proliferation of certain pathogens - germs/microbes. **Louis Pasteur** conceived the germ theory of disease and invented pasteurization to kill all the nasty germs.



Mainstream medicine is built on this theory that disease comes from the outside by pathogens invading the body and is inflicted upon the innocent helpless person.

According to Pasteur:

- Germs, or microbes, cause disease
- Germs invade the body from the outside, i.e., air, water, or food
- Human blood is sterile and can only be infected by outside microbes
- Germs are monomorphic, i.e., they have only one form and can be identified by species

William Koch attempted to add to Pasteur's germ theory by proving that a specific type of germ caused a specific disease, that the germ would be found in all people suffering from that particular disease but not healthy people, and that every person exposed to these germs would fall ill with that disease.

This theory was blown apart when he discovered that healthy people could carry the germs of certain diseases and yet show no symptoms and that some people could even be exposed to virulent germs yet not catch the disease.

Regardless of this controversy in the late 1800s, the Germ Theory was quickly adopted by the medical powers of the day. This theory that microorganisms invade from outside the body empowered the medical and pharmaceutical industry as guardians of human and animal health. So people became dependent on the medical/drugs industry for information and protection from disease. Thus, Modern Medicine was born.

Historically those who presented findings that challenged the long held dogma of the Germ Theory were silenced. Individuals such as **Royal Raymond Rife**, **Professor Antoine Bechamp**, **Claude Bernard** and numerous others provided substantial evidence revealing the true nature of the human microbiome.

Thankfully brave new researchers are breaking free from the old dogma that has locked us into a failing health and ecosystem. Their efforts are providing information, that when understood, changes our view of the very basis of life. This new information can propel us towards restoring not only human health but the very health of our planet.

What is 5G

Wikipedia: “5G is the fifth generation wireless technology for digital cellular networks that began wide deployment in 2019. As with previous standards, the covered areas are divided into regions called "cells", serviced by individual antennas.”



I find it interesting that military terminology - **“deployment”** is used to describe the 5G activation.

Thousands of studies link low-level wireless radio frequency radiation exposures to a long list of adverse biological effects, including: DNA single and double strand breaks, oxidative damage disruption of cell metabolism, increased blood brain barrier permeability, melatonin reduction (increased sleep disturbance), disruption to brain glucose metabolism and the generation of stress proteins (increased anxiety and anger).

In aggregate, for the high frequency (radiofrequency-RF) part of the spectrum, these reviews show that RF radiation below the FCC guidelines can result in: carcinogenicity (brain tumors/glioma, breast cancer, acoustic neuromas, leukemia, parotid gland tumors), genotoxicity (DNA damage, DNA repair inhibition, chromatin structure), mutagenicity, teratogenicity, neurodegenerative diseases (Alzheimer’s Disease, Amyotrophic Lateral Sclerosis), neurobehavioral problems, autism, reproductive problems, pregnancy outcomes, excessive reactive oxygen species/oxidative stress, inflammation, apoptosis, blood-brain barrier disruption, pineal gland/melatonin production, sleep disturbance, headache, irritability, fatigue, concentration difficulties, depression, dizziness, tinnitus, burning and flushed skin, digestive disturbance, tremor, cardiac irregularities, adverse impacts on the neural, circulatory, immune, endocrine, and skeletal systems. From this perspective, RF is a highly pervasive cause of disease!

It is interesting to note that the new 5G applications using higher frequency ranges above 6 GHz to 100 GHz and beyond, utilize submillimeter and millimeter waves. The military uses millimeter waves in the 96GHz range in crowd dispersal guns called Active Denial Systems to penetrate the top 1/64 of an inch (0.39624 mm) layer of skin on the targeted individual, instantly producing an intolerable heating sensation that causes them to flee.

Dr. Paul Ben-Ishai pointed to research that was commissioned by the U.S. Army to find out why people ran away when the beam touched them. “If you are unlucky enough to be standing there when it hits you, you will feel like your body is on fire.” The U.S. Department of Defense explains how: “The sensation dissipates when the target moves out of the beam. The sensation is intense enough to cause a nearly instantaneous reflex action of the target to flee the beam.”



Free radicals are molecules that have one or more electrons too few or too many, and they will damage any biological molecule (flesh & tissue) they come in contact with. Fullerene C60 is proving to be the world's best neutralizer of harmful free radicals and a recyclable-by-the-body universal, antioxidant (able to donate as well as accept multiple electrons without being used up).

Acting as a perfect antioxidant, fullerene C60 is comparable to 100-1000 times more active, with greater effect, than other antioxidants such as that of vitamin E and C carotenoids, flavonoids, ionol, etc.. One molecule of conventional antioxidant is generally required to neutralise one radical. At the same time, a single C60 fullerene molecule is able to neutralise an unlimited quantity of active radicals. It is an antioxidant-catalyst.



Antioxidants get 'used up' as well as eliminated by the kidneys and many are not fat-soluble and can't neutralize many types of chemicals and free radicals, nor reach lipid-rich locations in the human body. Lipofullerene C60 is recycled by the cells providing continuous protection from free radical damage.

Furthermore, C60 does not suppress the natural level of free radicals in the body, but becomes active only under conditions of their increased concentration. The mechanism of fullerene’s antioxidant effect is fundamentally different from that of other antioxidants.

The effectiveness of C60 fullerene to protect cells from degradation is beyond anything known to date and really cannot be compared to vitamin C or any other antioxidant free radical scavenger. Fullerene C60 even neutralizes normally lethal doses of hepatotoxins (a toxic chemical substance that damages the liver) as demonstrated in the famous rat longevity study conducted in France.



What Is C60?

An Extraordinary Form of Carbon Charcoal

We humans are carbon based creatures, as is all biological life on our planet. C60 is a naturally occurring form of sixty carbon atoms joined in perfect structure that

forms a geometrical sphere made of 20 hexagons and 12 pentagons which has become known as a Bucky Ball (after Buckminster Fuller).




C60 is a naturally occurring form of carbon crystal with perfect molecular structure that forms a geometrical sphere made of hexagons and pentagons which has become known as a Bucky Ball, fullerene or Buckminster fullerene.

Until now carbon was believed to exist in 3 basic forms, charcoal, graphite and diamond. The discovery of C60 - carbon in crystal form is challenging the basic foundation of chemistry and physics.

Consider that activated charcoal is commonly sold as a purifying agent for water and as a supplement given to people who are suffering acute poisoning. Charcoal absorbs the poison by drawing it into its pores. The unique quality of C60 is that it adsorbs as opposed to absorbs free radical toxins. This means that it binds them to its external structure then safely removes them from the body.

Star Dust

Being a natural substance generated from star dust - the very origin of life, it seems that C60 fullerene provides the matrix which assists the body (and any organism) to return to its “pristine condition”.

The C60 Rat Study Conducted in France

What made lipofullerene C60 a worldwide phenomenon was the now famous rat study led by Fathi Moussa and his team. What is so incredible about this study is that the actual reason for the experiment was to determine the lethal dose of C60. These scientists split the rats into 3 groups (a base-line group, control group and test group) and gave the test group C60 absorbed in olive oil. C60 is not water soluble but it is fat soluble, so they deduced that olive oil would be a suitable base. As opposed to finding any toxic level, let alone a lethal dose for the C60, they were shocked with the results.

They discovered that the lifespan of the test group rodents was extended by 90%

They also discovered that the test group did not develop tumours while the base and control groups did. Many experiments have now been done on C60 that show its incredible healing potential and many who now believe it can do the same for humans as it did for rats. After all, rats and humans have the same basic

physiology, similar organs, and similar body plans and even suffer from the same diseases.

How Does C60 Work to Prolong Life?

It is not known how C60 greatly extends the life of mammals. Hypotheses vary from extremely effective antioxidant action to DNA-demethylation. The demethylation process is necessary for epigenetic reprogramming of genes and is also directly involved in many important disease mechanisms such as tumour progression. The DNA-demethylation theory fits the fullerene animal trials more closely as they exhibited permanent rejuvenation on the genetic-molecular level after consuming C60. After only two dozen doses of lipofullerene C60, there are reports of old mice acquiring the problem solving power and memory of young mice, and rats nearly doubling their expected lifespan.


Being a completely stable molecule allows it to continuously provide the neutralizing or balancing role adhering free radicals.



The owners are committed to using sustainable organic farming practices without the use of any chemical pesticides or fungicidal sprays. This year's lab report for the oil in our

Cellular Communication Network
