




PROHIBITED USAGES



Do not cover shackle center bump with wide tow strap. Shackle bump will split or tear single wide tow strap under load if strap is covering bump. Only use tow strap looped end and a properly fastened slip knot to avoid tow strap damage. Please refer to "Acceptable Usages" section for proper tow strap slip knot application.






DO NOT OVERLAP TOW STRAPS




PROPERLY ATTACHED TOW STRAP SLIP LOOP



TWO TREE SAVERS OR STRAPS


DOUBLE SOFT SHACKLES




SINGLE TREE SAVER, STRAP OR SOFT SHACKLE **SINGLE HOOK***






DOUBLE HOOKS*
