CLOTHING RENTAL AGREEMENT

Rental Term: 5 calendar days (term starts on the day items are received by the RENTER, term ends when the items are sent back/brought back to Bikinis and Stuff, confirmed by a valid tracking number/ or drop off.

Items will be thoroughly checked by us before they will be shipped or given to the next renter. If there are any issues with the items provided, please advise Bikinis and Stuff at the earliest convenience. In the event that after delivered to or collected by you, any of the items are lost, stolen, damaged beyond repair, disappears, or is not returned for any reason, the renter will be liable for replacement costs and not receive their refundable deposit. Any damages outside of normal wear and tear will also be assessed. Bikinis and Stuff has full discretion on assessed damages and the renter is liable for repair costs.

If not picking up at our location, your items will be shipped to your specified location and will arrive by the date requested. When you return your items, you will need to advise Bikinis and Stuff either by phone (+27 84 8175 872) or email (BikiniStuffSA@gmail.com) that your items are ready to be shipped back to us, proved with a valid tracking number.

Refundable Deposit

Bikinis and Stuff requires a refundable deposit from the person renting our items. In the event of any lost or damaged goods at the time the rental is returned, the refundable deposit will be used to cover the charges. Bikinis and Stuff will make reasonable efforts to contact the client before any charges are taken from the refundable deposit.

RENTAL TERMS AND CONDITIONS

- 1. The Renter shall pay Bikinis and Stuff full compensation for replacement and/or repair of any items which is not returned because it is lost or stolen or any items which is damaged and in need of repair to put it into the same condition it was in at the time of rental, normal wear and tear excepted. Bikinis and Stuff will issue an invoice for replacement or repair to the Renter and the amount will be taken from the renters refundable deposit.
- 2. The items shall be delivered to the Renter and returned to the Bikinis and Stuff at the Renter's risk, cost and expense. If the items are not returned during or at the end of the rental term, then the rental charges shall continue on a full term basis for any additional term or portion thereof until the items are returned. A penalty fee of 20% of the total rental fee will be billed to the Renter for late returns.
- 3. No refunds will be given for any rented items or portion thereof which is claimed not to have been used.
- 4. A sanitary liner or sticker must be worn at all cost when wearing our bikinis, for sanitary and hygiene purposes. If items are received back with discharge, items will be seen as damaged and a washing fee of R220 per item will be taken from the Renter's deposit. Socks must be worn with our closed-style shoes for hygiene purposes.
- 5. If any make-up, tanning or dirt cannot be removed from the items, items will be seen as damaged and a damaged fee will be charged to the Renter.
- 6. These terms are accepted by the Renter upon delivery of the terms to the Renter or the agent or other representative of the Renter.
