

Enviro Thinners No. 1

Thinning and Cleaning Solvent



DESCRIPTION

Enviro Thinner No.1 is a solvent used for thinning and cleaning of certain Envirosystems products. Enviro Thinner No.1 should always be used in accordance with the instructions contained in the technical data sheet for the appropriate Envirosystems product.

PACKAGING

Enviro Thinners No. 1 is supplied in 4L pails and 20L drums.

SHELF LIFE

Enviro Thinner No.1 is sensitive to temperatures and problems may arise with pressure build up within the drums if exposed to high temperatures for long periods of time. When opening these drums care must be exercised in releasing the internal pressure. The recommended storage temperatures are between 10-25°C. Always check product quality before using after prolonged periods of storage. If unsure, please contact Envirosystems for advice.

PHYSICAL PROPERTIES

HEALTH & SAFETY ADVICE

Enviro Thinner No.1 contents are flammable. Keep away from naked flame. In the event of fire, extinguish with CO₂. Always provide adequate ventilation and wear personal protective equipment during application. Avoid breathing vapours and contact with skin. If swallowed, DO NOT induce vomiting. Give glass of water and seek medical assistance. If contacted with skin, wash off splashed material with soap and water. If irritation occurs seek medical advice. Refer to the Safety Data Sheet for full safety and handling procedures.
