If our tile is proven to have a manufacturing defect, we will replace the tile, free of charge. And, if we do not have the same material, we will replace them with the comparable material as determined by Ottimo Ceramics. Products should be inspected prior to installation and any defects, colors, shading and incorrect format sizes must be reported immediately in writing within 30 days of invoiced date. **INSTALLATION** of product constitutes the **ACCEPTANCE** of the product. **We cannot accept returns or pay for any labor charges and therefore excluded from this warranty.**

Ottimo Ceramics is not liable for any direct or indirect costs associated with the repair or replacement of the product including removal, installation or reinstallation of the product and this warranty only applies to installations made by actively licensed tile contractors.
