

BREYERFEST[•] CHILDREN'S and YOUTH SHOWS 2024 EXHIBITOR'S CODE OF CONDUCT

The focus of the BreyerFest Children's and Youth (BFCY) Shows is to create an environment conducive to <u>learning</u>, <u>fun</u>, and <u>fairness</u> in which everyone can feel comfortable. The goal of this document is to set a standard of sportsmanship for the Breyer BFCY Shows (the "Show(s)") under which ALL entrants, and their parents/legal guardians, and guests are bound.

Violations of this Code may result in removal from the show and forfeiture of entry fees, placings, and or prizes (if applicable),. If you have concerns about a violation of this Code, please report them to the Show Managers immediately so that prompt action may be taken.

NOTE: You will receive a DocuSign® link directly from Breyer after ticket sales for the event close. No hard copies of this form are accepted.

1. Entrant, entrant's parents/legal guardians and entrant's guest(s) agree to abide by the rules of the Show. Entrant and entrant's parent/legal guardian are responsible for reading <u>and understanding</u> the rules of this Show, which may be different from other shows in your area.

2. Entrant and entrant's parent/legal guardian attests that <u>neither</u> the entrant <u>nor</u> the Breyer models they are exhibiting at the BFCY Show have ever shown at any North American NationalsTM (NAN) show.

3. Decisions of the Judges, Stewards, and Show Managers are final and binding in all respects.

4. Entrants, their parents/legal guardians, and guests are expected to demonstrate respect at all times to fellow exhibitors, Judges, Stewards, Staff members, Breyer representatives, spectators, and Kentucky Horse Park staff. Should an issue arise that needs to be resolved, you agree to bring the issue to the Show Managers or Head Steward for resolution rather than acting on the issue independent of the Children/Youth Show Staff.

5. Displays of poor sportsmanship before, during or after the Show are unacceptable. This includes questioning the staff over their decisions in an impolite manner, behaving disrespectfully towards entrants, their parents/legal guardians and/or guests OR the entries, and/or making derogatory comments on the Internet regarding the same. Actions deemed inappropriate by Show staff may result in an entrant and their parent/legal guardian or guest being asked to leave the show with no expectation of entry fee refund.

6. Inappropriate or disrespectful language is not permitted in the Show hall and surrounding areas.

7. Possession of alcoholic beverages, illegal substances (including tobacco products held by a minor), and/or carrying weapons/firearms are not permitted at BreyerFest.

8. Entrant and parent/legal guardian acknowledge that BreyerFest and the Show may be broadcast or otherwise publicized, and purchasing a ticket to BreyerFest, attending BreyerFest, and/or entering this show constitutes your consent to be photographed, filmed, and/or otherwise recorded by Reeves and/or Breyer, including any minor(s) admitted with you or without a ticket, and for Reeves and/or Breyer to use your appearance and/or voice, and/or that of any minor(s) admitted with you with or without a ticket, in any and all media in perpetuity and without compensation to Holder or such minor(s) for any purpose whatsoever including without limitation commercial and/or promotional use, in connection with BreyerFest, Reeves and/or Breyer.

We welcome feedback about all aspects of the event, but comments on Facebook, BreyerHorses.com, and/or Breyer social media that are combative, attacking, or not in keeping with the spirit of the event will be removed.

By registering for either the Children or Youth Model Horse Shows, you are accepting the entire Code of Conduct, and entrant and parent/legal guardian and your guest(s) agree to abide by this Code of Conduct at all times.
