

# BreyerFest Swap Meet

## July 14 & 15, 2022

The 2022 Swap Meet will be held on Thursday July 14<sup>th</sup> and Friday, July 15<sup>th</sup> in the Clarion Hotel Ballroom! The doors will open to the public at **7:30 pm** and will close promptly at 11:00 pm each day. **Applications must be received by April 15, 2022.** The Swap Meet is the perfect place for an individual seller looking to sell, trade, or even buy older, vintage, or surplus models.

**The Swap Meet is not open to Breyer retailers, customizers, or artists.** Retailers are invited to sell at the BreyerFest® Marketplace, and Artists and Customizers are welcome to participate in the Artisans' Gallery. Current 2022 Breyer merchandise (including Special Runs and Limited Editions) is not permitted to be sold or traded at the Swap Meet. Thank you for understanding. If you would like to upgrade to include a virtual listing, you may do so via the Virtual Application available on the website.



Applications will be processed and tables will be allocated on a first-come, first-served basis. You must be a BreyerFest VIP or All-Access ticket holder to exhibit at the Swap Meet. **Only one seller per table is permitted.** Helpers and attendees do not need a ticket to attend or shop. Table fees are \$50 for one table per night, or \$80 for two tables per night; there is a **two-table limit**. The \$50 fee includes one 6' table and two chairs; the \$80 fee includes two 6' tables and four chairs. All additional shelving brought by an exhibitor must be properly secured or, at the sole discretion of Breyer, you will be asked to remove it.

**Set-up for all exhibitors is 3:00 pm – 7:00 pm on the day you are exhibiting. Please be sure to have your area set up at least 30 minutes prior to the opening of the Swap Meet each night. Your cooperation is greatly appreciated!**

Payments can be made by check or credit card. We accept Visa, Master Card, American Express and Discover. Please make all checks payable to Reeves International, Inc.

## Swap Meet FAQs 2022

Thank you for your interest in the 2022 BreyerFest Swap Meet! In order to ensure a good experience for everyone, and to maintain security, there are a few reminders we would like to bring to your attention:

- Submitting an application does not constitute acceptance into the Swap Meet. Pictures of the seller's items must be approved by Breyer before acceptance. A confirmation letter will be sent to accepted sellers.
- The operating hours of the Swap Meet at the Clarion Hotel are from 7:30 pm to 11:00 pm on Thursday and Friday. To ensure security, we will insist on closing promptly at closing time.
- All table holders must be VIP or All-Access ticket holders to show in the Swap Meet. A BreyerFest ticket is not required for those viewing and shopping. Those helping with set-up do not need be ticket holders.
- Breakdown will begin at the end of each evening's sale hours at 11:00 pm, unless you are participating for both nights. All merchandise and fixtures are expected to be removed from the ballroom by close of doors that evening. The Clarion ballroom must be vacated by **midnight**.
- Breyer® will do its best to ensure security of the Clarion ballroom during off hours. However, since we do not have the power to guarantee a completely secure facility, we strongly recommend that you consider removing valuable merchandise each night. Breyer® is not responsible for stolen or damaged merchandise.
- No one is permitted to enter the Swap Meet during off hours unless personally accompanied by a Breyer staff member. Under no circumstances will anyone be permitted to enter with any agent of the Clarion and neither are any managers of the Clarion permitted to offer this service. Therefore, please be certain you have anything you need with you when you leave each evening at closing time. Any parties found in violation of this rule will be asked to remove themselves and their items from the Swap Meet without a refund.
- The Swap Meet is provided by Breyer® as a courtesy to sellers to benefit from the excellent sales environment at BreyerFest. However, as we are committed to providing an outstanding BreyerFest® experience for our attendees, we cannot avoid some overlap of events at the Kentucky Horse Park and Swap Meet operating hours. We ask for your understanding that our primary responsibility is the entertainment of attendees of BreyerFest® and that we do our best to promote the Swap Meet in our BreyerFest® events literature.
- Swap Meet attendees are solely responsible for reporting any state and local taxable income.
