



COVID-PROTOCOL

provided by the Circuit Mettet | March 2021

I hereby declare that I have taken note of the "Covid-19 Protocol" set up by the Circuit de Mettet as part of the fight against the spread of the Covid-19 pandemic.

This document is part of the protocol governing the practice of physical and sporting activities in the Wallonia-Brussels Community, which came into force on 31/10/2020 and was amended on 08/03/2021.

I therefore undertake to respect the health and precautionary measures put in place in order to obtain an authorisation to access the infrastructures of the Circuit de Mettet.

The proposed activity consists of free and individual practice of motor sport on this outdoor infrastructure. It is not a collective sport, nor a collective training, and even less a competition.

1. General (and common sense...) rules

- Stay home if you are ill or have symptoms
- Wash your hands often with soap and water, with hydroalcoholic gel for at least 30 seconds
- Wear a mask, except during the activity (exception not valid for a pilot and his co-pilot)
- Keep at least 1.5m distance
- Limit physical social contact
- Grouping of maximum 4 allowed with mask
- Removing the mask to eat/drink/smoke is possible but keep a distance of 5m

2. Registration

Administrative procedures must be completed electronically and in advance (registration, payment, supporting documents, briefing).

On site, interaction with the staff will be limited to the strict minimum. No registration will be possible on site.

3. Access to the Circuit

No access will be allowed without prior authorisation and outside of the communicated times. This access will be made only via the entrance that will have been mentioned to you.

Each participant may be accompanied by a maximum of 3 people. In general, please limit the number of people to what is strictly necessary. Any other external visitor will not be allowed access to the site.

4. Paddock

There are spaces reserved for the participants' "bubbles". You are required to respect these areas.

Distance rules must also be applied in the tents, allow 10m² per person.

On-site accommodation is not allowed. All participants must leave the site as soon as possible after the training sessions are over.

5. Toilets and showers

Open public toilets are indicated on the site.

Access to these will be on an individual basis. Showers are not accessible.

6. Access to buildings

It is required not to enter a building or room without a valid and justified reason, to respect the social distancing measures and to wear a mask in ALL circumstances within the buildings.

7. Lifts

Lifts are only accessible to authorised persons, and ONLY ONE person at a time.

We thank you for respecting all these measures which allow us to resume our activities in complete safety and with the necessary common sense and courtesy. These measures can be modified at any time according to the injunctions of the authorities.

A Health Safety Manager will ensure that the rules are strictly adhered to throughout the activity.



Failure to comply with the above measures will result in suspension of access to the Circuit for the entire 2021 season and direct exclusion from the activity.

I hereby declare that I have taken note of the above recommendations and that I will respect those provided on the site.
I also declare on my honour that I have not had any of the symptoms mentioned in point 1 of this charter for 14 days.

If I should become a carrier of these symptoms between the signing of the charter and my arrival at the Circuit, I undertake not to come to the Circuit.
