preservatives.

CUT AND SIZE: Diameter: 6-16 mm

Length: 30-90 mm

80% should be of the declared size above.

Tolerance: 15% w/w less than 30 mm & 5% by count greater

than 90mm

BLANCH: This product is blanched sufficiently to inactivate the

peroxidase enzyme system.

**FREEZING METHOD:** Individual quick frozen (IQF)

ORGANOLEPTIC STANDARDS The product possesses a good characteristic normal odor,

flavor and aroma, typical of fresh carrots that have reached

right maturity. Free from objectionable flavor or odor.

**COLOR:** Reasonably uniform typical bright orange to yellow orange
