



IQF EDAMAME BEANS (GRADE A) * BELOW ZERO*

- INGREDIENTS:** Edamame without Shell. *No preservatives and or additives.*
- CALIBER:** < 850 pcs/500g, but uniform
- BLANCH:** Product is blanched sufficiently to inactivate the peroxidase enzyme system
- FREEZING TECHNIQUE:** Individual quick frozen (IQF)
- ORGANOLEPTIC:** The product possesses a good characteristic flavor and aroma. Typical of Edamame beans Free from objectionable flavor and odor.
- COLOR:** Bright green color
- TEXTURE:** Firm but tender
- MAJOR DEFECTS:** No tolerance for stones, glass, plastic, metal, hair, wood.
- MINOR DEFECT:** per 500g sample:
- 3 % by weight maximum (Blemish major)
 - 7 % by weight maximum (Blemish minor)
 - 8 % by weight maximum (Blemish total)
 - None EVM/FM
 - 5 % by weight maximum (Broken & Splits)
