

# FINANCIAL TERMS AND AGREEMENT

Effective January 15, 2017

## I. Enrollment Fees

### A. Enrollment fee (non refundable)

1. The initial enrollment fee for each child is \$45.00
2. A second child enrolled at the same time is \$25.00

## II. Tuition Fees

### A. Full time enrollment

	Weekly Amount If Fees Are Paid On Monday	Weekly Amount If Fees Are Paid After Monday
Children under age three or not potty trained (nursery/toddler)	\$124.00	\$130.00
Children over age three and potty trained (pre-school)	\$119.00	\$125.00

### B. Part time enrollment

1. Children must be enrolled for a pre-set number of days (minimum 2 days)
2. Services will be offered at the following rates: \$35.00 per day

### C. Drop in program

1. Children must be enrolled for regular drop in program
2. A drop in fee of \$50.00 is due each month to keep your child on the drop in list
  - a. This monthly fee qualifies you for one day of attendance per month
  - b. Additional days will be charged \$50.00 per day

### D. School age children

1. Afternoon pick up only (\$52.00 per week)
2. Morning delivery and afternoon pick up at area schools (\$57.00 per week)
3. Part time rate for before/after school services: \$15.00 per day
4. Child care during holidays, summer vacations, snow-days, etc. will be provided at the rate listed above for pre-school children.

## III. Terms Of Agreement

- A. Each child's weekly rate will be based on the number of days for which the child is enrolled. No refunds, credits or discounts are made for absences due to such things as sickness, vacations, weather, holidays, etc.
- B. All fees are due weekly in advance. A 10% late fee will be added when the fees are not paid on time. Childcare will be suspended if fees are two weeks past due. Monthly or bi-weekly payments can be arranged by special agreement if paid in advance.
- C. A service charge equal to the amount allowed by law will be assessed for returned checks.
- D. You will be asked to give a one-week notice before withdrawing your child. Your regular fees will be due for this week.

In consideration of my child being enrolled at Little Angel Day School. I agree to waive trial by jury, and agree to resolve any and all disputes related in any manner whatsoever to my child being enrolled at and attending this school by binding arbitration pursuant to the applicable Rules Of The American Arbitration Association, and judgment on the award rendered by the arbitrator may be entered in any Court having jurisdiction thereof. I have read and agree to all the terms of this agreement. My child will be enrolled at Little Angel Day School and for these services I agree to pay the regular fees and abide by the terms of this agreement.
