Parents of teenagers are informed that, if children are under 14 years of age, they shall be accompanied at all times by an adult family member (or another adult member nominated by the parents) which **excludes Amahs** whilst on Club premises and must be within the view when in or around the pool as the adult family member is responsible for the welfare, safety and behaviour of the child. No unsupervised children under 14 years of age including attending swimming lessons are allowed in the swimming pools or surrounding areas of the pools defined by the barriers.

The only exceptions are below but this privilege may be withdrawn upon observed misconduct of your child(ren):

1. Children aged 12 and 13 years where the parents have applied for permission to allow their children to sign chits and unaccompanied access to all Club areas except Fitness Centre room, Golf course/Driving Range and Swimming Pool.
2. Children aged 6 up to 11 years where the parents have applied for permission to allow their children to sign chits and unaccompanied on Club premises to attend/participate in specific activities/lessons such as Auskick, Dance, Football, Library, Music, Rugby (& Touch), Tennis or Youth Club. Parents must take responsibilities to collect their children immediately after the activities/lessons. Repeat offenders may have this privilege taken away.
3. I acknowledge and understand the Panaga Club Swimming Pool rules as they appear in the Swimming Pool Complex. I will endeavour to obey these rules at all times, and ensure that my family members and guests do the same.

Pool Rules – For your safety & enjoyment, please take note of the information and rules below:

INFORMATION

SAFETY IS YOUR responsibility for yourself and children in your care
 LIFEGUARDS NONE on duty
 POOL WARDENS OBEY their instructions and bring any concerns to their attention

RULES

USERS MUST shower BEFORE entering pool
 MUST be accompanied by an adult if under 14 years old
 MUST have "proper" swimwear
 Infants/toddlers MUST have "swim nappies"
 Incontinent children MUST not use main pool
 WET DECK NO running or unsupervised ball games
 NO footwear (except for "operational reasons")
 POOL NO throwing or pushing of people into pools
 NO unsupervised ball games
 ONLY DIVE into deep end of main pool
 SLIDE ONLY ONE child to use the slide at a time
 FOOD & DRINKS NOT permitted in pool or "wet deck" area
 Meals only to be served at round tables

Always be conscious of and respectful to all other pool users. The "wet deck" is the tiled area surrounding the pools.
