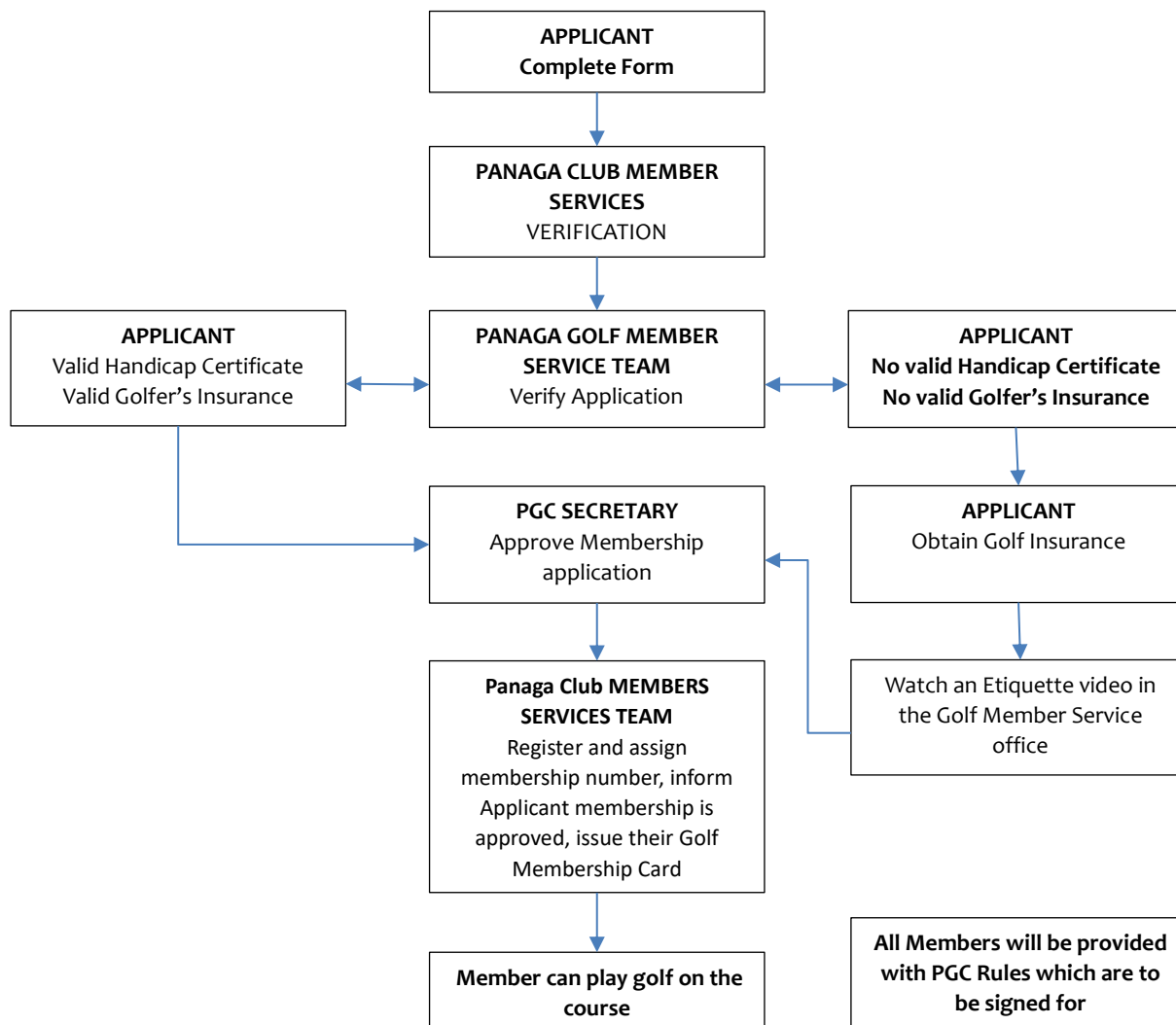

DRESS CODE



A neat and tidy standard of dress is required on the course and in the clubhouse at all times. Members or visitors not complying with the dress code may be asked to leave the premises.

WOMEN

- Golf dresses or sleeveless shirts with a collar, or be of a recognisable golf design.
- Shorts and skirts must be of an appropriate length with socks of any colour or length.
- Socks of any colour or length must be worn.
- Golf shoes



MEN

- Shirts must have a collar and sleeves, or be of recognisable golf design, and tucked in at the waist.
- Tailored trousers or appropriate length tailored shorts.
- Socks of any colour or length must be worn.
- Golf shoes

Unacceptable clothing on the course:

Trainers, denims, track suits, vests, football kit (or other sports) kits, cargo shorts, beach wear, non-golf attire tee shirts. Headgear to be worn correctly i.e. peaks facing forward.
