



## Sage to Summit - Climbing Gym

### Ongoing Monthly Membership Agreement

**Monthly Billing** = Membership dues are automatically billed on the first of each month. Members have two payment options, ACH billing or credit/debit card. If a member chooses to pay their monthly dues with a credit/debit card, a 3.5% surcharge will be applied. It is the responsibility of the member to keep current ACH and/or credit card on file with the gym for monthly billing.

**Family Memberships** = Family and couple pricing is for people living as domestic partners in the same household. A roommate does not apply to a family membership. Children 18 and under can be part of a family membership. Adult children do not qualify. Documentation such as a license with the same address is required.

**Cancellation** = Members can cancel their membership at any time - the cancellation of their account takes effect with the start of the next billing cycle. Example - if you cancel your account on March 15th, your account will officially cancel starting on April 1st since you have already paid for the month of March.

**Freezing** = Members can freeze their account starting on the first of the month for an \$8 fee instead of their regular monthly dues. We must receive the request (in-person or phone) before the first of the month the member wishes the freeze to start in - we are unable to offer retroactive freezes, please plan ahead. A members' account must be frozen for at least one month and can be un-frozen anytime after the first month - the member will then pay a prorated amount of their monthly dues.

**Past Due Balance** = If a member has a past due balance, we require that the balance is paid before the member uses the gym again. If a member has more than two months of past due balance we will cancel their account and they will need to sign-up as a new member again if they wish to restart their membership.

**Membership Initiation Fee** = We charge an initiation fee for all ongoing monthly memberships. If a member decides to cancel their account and then in the future start a membership again, the initiation fee would be charged again. We recommend weighing the costs of the initiation fee vs the freeze fee to see which option would be best for your situation.

**Respectful Environment** = We expect all of the members and guests of the climbing gym to treat one another and the staff with respect. Harassment of any kind is not allowed and will lead to the person being asked to leave.
