Section 4. First aid measures

Description of necessary first aid measures

Section 6. Accidental release measures

Methods and materials for containment and cleaning up

Spill : Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Section 7. Handling and storage

Precautions for safe handling

If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator. Section 8. Exposure controls/personal protection
