

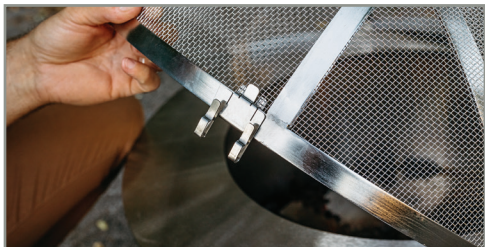

SPARK SCREEN INSTRUCTIONS



STEP 1

Attach the spark screen clip next to the vertical bar on the non folding side of the spark screen.



STEP 2

Line up clipped spark screen with the Outpost™ grill opening.



STEP 3

Insert clipped spark screen into the Outpost™ grill opening until it's securely in place.

Enjoy!

Once you get your fire going, close the spark screen to keep sparks and embers safely away from your property.



REMOVAL

Wait until the fire has died down. Press down on both clip levers and pull spark screen up and away.



Breeo Tip

We recommend keeping the spark screen clip in the same spot on the spark screen to reduce visible scratches.



FOR YOUR SAFETY

The Breco X Series® Spark Screen is designed for outdoor use only.

Do not move or store your X Series Spark Screen until all ashes and coals are extinguished and all surfaces have cooled completely. If fire pit is still warm, use gloves as a precaution to remove the screen.

All surfaces of the fire pit and spark screen will become extremely hot when in use. To avoid burns, don't touch any part of the fire pit until it's completely cool (unless you're using protective gear like hot pads, potholders, etc.).

Exercise the same caution you would with any open fire. ***When using your X Series Spark Screen, never leave it unattended, especially around children and pets.***





Breero, LLC warrants to the original purchaser that the Breero Fire Pits and Accessories are free from workmanship and material defects during the lifetime of the original purchaser.
