

Modern Slavery Statement

This statement is made pursuant to the Modern Slavery Act 2015 and outlines the steps taken to minimise the risk of modern slavery in our business and supply chains. This statement covers the period 1st January 2021 to 31st December 2021.

Organisational Structure

This statement applies to International Cookware Limited which is a subsidiary of the company La Maison Française Du Verre, incorporated in March 2020 and headquartered in France. La Maison Française du Verre as a group (“LMFV Group”) primarily manufactures and markets cooking and baking products made in borosilicate glass and tempered soda-lime glass for tableware (drinking glasses, cups, plates, salad bowls, etc.). It also markets kitchen products made in other materials such as ceramics, stainless steel and aluminum.

International Cookware SAS, which is a subsidiary of the company La Maison Française du Verre, holds the license for the Pyrex® trademark, granted by Corning Inc., for Europe, Middle East and Africa. LMFV Group’s sales are made in more than 130 countries. In addition, LMFV Group recently developed Ôcuisine®, a trademark registered worldwide. In tableware, LMFV Group owns the Duralex® trademark worldwide, with the exception of South America, as well as Vereco® and Ovenchef®.

LMFV Group operates two manufacturing units in France, at Châteauroux site (Indre) for borosilicate glass and at La Chapelle Saint-Mesmin site (Loiret) for soda-lime glass. It has a distribution subsidiary in the United Kingdom, two subsidiaries acting as agents in Italy and Spain, and several representative offices.

Supply Chain

LMFV Group understands there can be significant risks in the supply chain. To combat these risks, we ask our suppliers to sign a supplier charter sustainable development to confirm:

- No child labour
- Fair wages
- Working conditions are safe and hygienic
- Employment is freely chosen
- Comply with all relevant national laws
- Treat employees fairly and in a non-discriminatory manner

- Evaluate supplier contracts to ensure they incorporate the Modern Slavery Act
