I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, hereby release, waive, discharge, and agree not to sue **Baffin, Wasatch Mountain Club, REI,** their employees, volunteers, sponsors, partners, or any affiliated entities (collectively, "the Released Parties") for any and all liability, claims, demands, or causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained while participating in this event.

3. Medical Fitness

I certify that I am physically fit and have not been advised otherwise by a qualified medical professional. I agree to inform the event organizers of any relevant medical conditions that may affect my ability to safely participate.

4. Emergency Authorization
