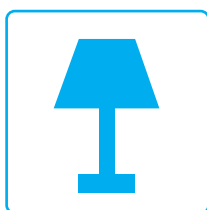


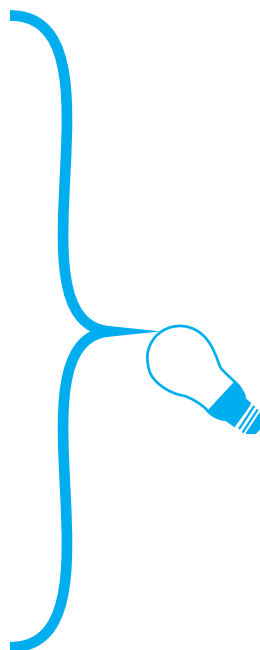
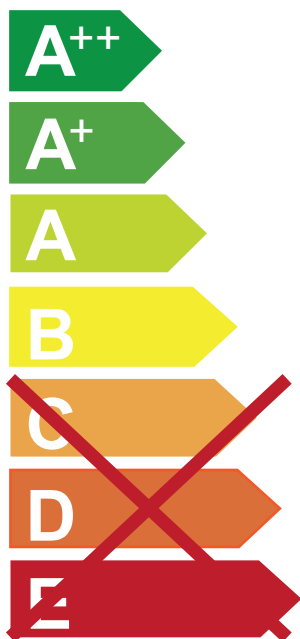

INFORMATION TO USERS
