

Terms and Conditions

Agreement between User and Nusep.us

Welcome to nusep.us. The nusep.us website (the "Site" is comprised of various web pages operated by NuSep Inc. ("NuSep"). Nusep.us is offered to you conditioned on your acceptance without modification of the terms, conditions and notices contained herein (the "Terms"). Your use of nusep.us constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

Nusep.us is an e-commerce site.

This Site is limited to NuSep customers in North America and is designed to offer special deals just to local customers. This site offers a membership plan that is free to join. NuSep sells a lot of lab supplies including but not limited to precast gels, buffers, stains, and blotting paper. NuSep also works with partners and acts as a distributor to sell their products. NuSep's focus is on protein electrophoresis and selling products related to it.

Privacy

Your use of nusep.us is subject to NuSep's Privacy Policy. Please review our Privacy Policy, which also governs the Site and informs users of our data collection practices.

Electronic Communications

Visiting nusep.us or sending emails to NuSep constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy an legal requirement that such communications be in writing.

Your Account

If you use this site, you are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your account or password. You may not assign or otherwise transfer your account to any other person or entity. You acknowledge that NuSep is not responsible for third party

access to your account that results from theft or misappropriation of your account. NuSep and its associates reserve the right to refuse or cancel service, terminate accounts, or remove or edit content in our sole discretion.

Children Under Thirteen

Cancellation/Refund Policy

NuSep strives to provide exemplary customer service and is willing to refund or exchange products under certain conditions.

If customer wants to return a product:

This applies when customer orders the wrong product or for some other reason wants to return the product.

To be eligible for a refund, customers are expected to notify NuSep within 5 business days of delivery date. Customers are responsible for shipping back the wrong product and provide proof of purchase. Upon receipt of the product, NuSep will refund the customer.

After the initial 5 business days, customers are eligible to exchange the product or receive store credit if they notify NuSep within 30 days of delivery date. Customers are responsible for shipping back the product and provide proof purchase. Upon receipt of the product, NuSep will either provide customers with a code that is equivalent to store credit or ship out the exchanged product. Customers are responsible for all shipping and handling costs as well as additional expenses that may arise from this transaction.

If NuSep delivers the wrong product or a damaged product:

This applies if the product arrives damaged or the incorrect product arrives as a result of NuSep. NuSep will replace the product or offer a refund at no additional expense to the customer.

To be eligible for a refund, customers are expected to notify NuSep within 5 business days of delivery date and to provide a receipt as well as proof of damage (please contact NuSep regarding what is sufficient proof). Otherwise, after the initial 5 business days and within 6 months of delivery date, customers are only eligible for a replacement product or store credit.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTION AND/OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
