



## A MESSAGE TO OUR VALUABLE CUSTOMERS AND PARTNERS

Woodbolt Distribution, LLC d/b/a Nutrabolt is the parent company of Scivation, Inc. and the owners of the category leading XTEND® brand of branched chain amino acids. It has recently come to our attention that the Korean Ministry of Food and Drug Safety (the “MFDS”) has posted an image of a label purporting to be our XTEND® BCAAs on the [foodsafetykorea.go.kr](http://foodsafetykorea.go.kr) website, indicating that this product allegedly tested positive for the prohibited substance stanozolol. This is the first time we are learning of this allegation, as neither we, nor our Korean distribution partners, received any direct communication from the MFDS. The image on the website appears similar to a version of XTEND® BCAAs, Pineapple - 90 serving that we sell through e-commerce channels directly to consumers in Korea, but there is very little information about the product that was tested and whether that image even corresponds with the product in question. We have contacted the MFDS and are actively working to obtain information about the product in question, such as the lot number and expiration date, in order to assess its authenticity and conduct a thorough investigation.

First and foremost, we want to be clear that no XTEND® branded products of any kind, contain or have ever contained stanozolol or any other illegal anabolic steroid. In fact, the likelihood of any XTEND® BCAA product containing ANY prohibited substance, even as a result of cross-contamination, let alone intentional adulteration, is less than zero. Our XTEND® BCAA products are produced in facilities that are NSF Certified, one of the most rigorous certification standards available, and are tested and manufactured in strict compliance with current Good Manufacturing Practices for dietary supplements. Furthermore, XTEND® BCAA products are Informed Choice Certified, which reflects a commitment to quality through manufacturing audits and testing for WADA banned substances. We take extreme care and make every effort to create safe, effective products you can trust. That’s why our products are carried by the most reputable retailers in over 100 countries around the globe.

As the category leader in branched chain amino acids, XTEND® is extremely popular with and trusted by supplement users around the world, including fitness enthusiasts, professional athletes, and even military personnel. And yet, **Nutrabolt has never received a single verifiable report of a positive drug test for a banned or illegal substance resulting from the use of an XTEND® branded product.** In fact, in the last year alone, hundreds of thousands of units of XTEND® branded products have been sold on military bases across the country, to military personnel who are often subject to random drug testing, without a single report of a failed drug test.
