1 Briefly describe the organization's mission: Heart to Honduras partners with churches, educational and civic organizations, individuals and businesses to help the Honduran people realize their potential and develop gifted and capable local leaders to become agents of change who will transform their world for Jesus Christ.

4a (Code:) (Expenses \$ 434,428 including grants of \$ 168,361) (Revenue \$) 31 North American teams involving 319 people traveled to Central America to serve alongside local churches and individuals. These teams worked constructing homes, water cisterns, washtubs, and building improvements. They provided medical assistance, cared for the needs of community members, trained leaders, and engaged in relationships that will help the locals identify their own resources and potential. Heart to Honduras arranges travel, lodging, and meals through Honduran partner Corazon Para Honduras. Health care professionals saw 700 patients and provided services worth \$53,138 to the communities they visited.

4b (Code:) (Expenses \$ 236,250 including grants of \$ 212,017) (Revenue \$) Heart to Honduras (through Corazon Para Honduras) is equipping communities with sustainable models of work and development to provide clean water, secure housing, accessible medical care, a consistent food supply, adequate fair employment, as well as spiritual and educational opportunities. In 2017, Heart to Honduras built or improved homes, improved community sanitation and infrastructure, assisted schools and churches benefitting over 3200 individuals.

4c (Code:) (Expenses \$ 34,660 including grants of \$ 34,660) (Revenue \$) Heart to Honduras pairs sister churches creating partnerships between US and Central American churches. In 2017, 21 churches in Honduras participated in this mutually beneficial relationship. They also provided support to 119 pastors and families, and leadership training to develop strong community relationships.
