1 Briefly describe the organization's mission: Heart to Honduras partners with churches, educational and civic organizations, individuals and businesses to help the Honduran people realize their potential and develop gifted and capable local leaders to become agents of change who will transform their world for Jesus Christ.

4a (Code:) (Expenses \$ 226,898 including grants of \$ 133,417) (Revenue \$) Heart to Honduras (through Corazon Para Honduras) is equipping communities with sustainable models of work and development to provide clean water, secure housing, accessible medical care, a consistent food supply, adequate fair employment, as well as spiritual and educational opportunities. In 2018, Heart to Honduras built or improved 10 homes, improved community sanitation and infrastructure, assisted in building 4 schools and 5 churches benefitting over 5,400 individuals.

4b (Code:) (Expenses \$ 223,170 including grants of \$ 131,225) (Revenue \$) 22 North American teams involving 210 people traveled to Central America to serve alongside local churches and individuals. These teams worked constructing homes, water cisterns, washtubs and building improvements. They provided medical assistance, cared for the needs of community members, trained leaders, and engaged in relationships that will help the locals identify their own resources and potential. Heart to Honduras arranges travel, lodging and meals through Honduran partner Corazon Para Honduras. Health care professionals saw 1,000 patients and provided services worth \$27,000 to the communities they visited.

4c (Code:) (Expenses \$ 140,634 including grants of \$ 82,693) (Revenue \$) Heart to Honduras provides funds to Corazon Para Honduras for the building and operations of an overnight camp experience for youth groups from both Central America and the United States. Camp activities and a safe environment are provided so campers can hear about the love of Jesus Christ. Over 5,000 people attended camp in 2018.
